said parish of Llangattwg otherwise Llangattock from the parish of Llangynidr aforesaid."

And whereas drafts of the said scheme or representation have been transmitted to the patrons and to the Incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation and the patrons of the new parish of Beaufort and the Incumbents of the said new parish of Beaufort and of the parish of Llangattwg otherwise Llangattock have respectively signified their assent thereto.

And whereas Henry Charles FitzRoy Duke of Beaufort K.G. as the patron of the said parish or parochial chapelry of Llangattwg otherwise Llangattock has offered certain objections to the

proposed arrangements.

And whereas notwithstanding such objections the said scheme or representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme or representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrars of the said dioceses of Llandaff and of Saint David's respectively.

Now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that the time for the discontinuance of burials in such churchyards be post-

poned as follows, viz.:

In the Parish Churchyard of Downe, in the county of Kent, until the thirty-first day of August, one thousand eight hundred and ninety-six.

In the Parish Churchyard of Morthoe, in the county of Devon, until the thirtieth day of November, one thousand eight hundred and ninety-six.

In the Parish Churchyard of Bellingham, in

the county of Northumberland, until the thirty-first day of August, one thousand eight hundred and ninety-six.
