wards having been fixed by Order of Her Majesty in Council made in that behalf on the thirtieth day of May one thousand eight hundred

and ninety-six.

"Now I the said Archibald Bence Bence-Jones do hereby in pursuance of the said Warrant and appointment declare this to be my scheme for the purposes of the said Municipal Corporations Act 1882 amended as aforesaid and I hereby fix and determine that the boundaries of the wards of the said borough of Reigate shall be as follows namely:—

" The North-West Ward.

"The North-West Ward shall include so much of the said borough of Reigate as is comprised within an imaginary line commencing at a point on the western boundary of the borough on the north side of the Reading and Reigate Branch of the South-Eastern Railway Company's line of railway where the said boundary crosses the said railway thence proceeding eastwards along the north side of the said railway to the point where the said railway crosses Nutley-lane thence southwards along the centre of Nutley-lane to the point of intersection of Nutley-lane and York-road thence eastwards along the centre of York-road to the point of intersection of York-road and of Londonroad thence southwards along the centres of London-road and Tunnel-road to the point of intersection in the Market-place of Tunnel-road and Church-street thence eastwards along the centre of Church-street and north-eastwards along the centre of Croydon-road and across the said Reading and Reigate Branch Railway to the northern boundary of the borough thence westwards and southwards successively along the boundary of the borough to the point of commencement aforesaid.

"The South-West Ward.

"The South-West Ward shall include so much of the said borough as is comprised within an imaginary line commencing at the point aforesaid in the western boundary of the borough and proceeding along the boundary of the said North-West Ward as hereinbefore described as far as Market-place thence southwards along the centres of Bell-street and the road past Woodhatch as far as Salmons Cross-lane thence eastwards and southwards successively along the centre of Salmons Cross-lane to the southern boundary of the borough thence southwards westwards and northwards successively along the said boundary of the borough to the point of commencement aforesaid.

"The Central Ward.

"The Central Ward shall comprise so much of the said borough as is contained within an imaginary line commencing at the Market-place aforesaid and proceeding thence along the eastern boundary of the said South-West Ward as hereinbefore described as far as Smoke-lane and thence eastwards along the centre of Smoke-lane and south-eastwards along the centre, of Chartlane and eastwards along the centre of High Trees-road to Red Hill Common and along a footpath or road (the easternmost of two) running north-eastwards to the point of intersection with Whitepost Hill-road thence southeastwards along the centre of the said Whitepost Hill-road to the point of intersection with Upper Bridge-road north-eastwards along the centre of Bridge-road to the south side of the Reading and-Reigate Branch of the South-Eastern Railway Company's line thence westwards along the south side of the said railway to the point of intersection of the said railway with the Croydon-road on the boundary of the said North-West Ward herein-

before described thence south-westwards along the said boundary of the North-West Ward as hereinbefore described to the point of commencement aforesaid.

"The North Ward.

"The North Ward shall comprise so much of the borough as is contained within an imaginary line commencing at a point in the northern boundary of the borough at the intersection of the Croydon-road proceeding thence south-westwards along the south-eastern boundary of the North-West Ward hereinbefore described to the south side of the Reading and Reigate Branch of the South-Eastern Railway Company's line and thence eastwards along the northern boundary of the Central Ward hereinbefore described to the point of intersection of Linkfield-street and the said railway line thence northwards along the centre of Linkfield-street to the point of intersection of Linkfield-street and Cromwell-road thence eastwards along the centre of Cromwell-road to the point of intersection of Cromwell-road and High-street, Redhill, thence north-eastwards along the centres of High-street Redhill and Londonroad to the boundary of the borough at Gatton Corner thence eastwards along the northern boundary of the borough to the point of commencement aforesaid.

"The East Ward.

"The East Ward shall comprise so much of the said borough as is contained within an imaginary line commencing at a point in the boundary of the borough at Gatton Corner aforesaid and proceeding thence southwards along the eastern and southern boundaries of the North Ward as hereinbefore described as far as the point of intersection of Linkfield-street and the Reading and Reigate Branch of the South-Eastern Railway Company's line thence eastwards and southwards successively along the boundary of the Central Ward hereinbefore described to the point of intersection of Upper Bridge-road and Whitepost Hill-road aforesaid thence southeastwards and eastwards successively along the centres of Whitepost Hill-road and Mill-street and Hooley-lane respectively to the point of intersection of Hooley-lane and the Tunbridge Branch of the South-Eastern Railway Company's line thence in an easterly direction along the northern side of the said railway line to the eastern boundary of the borough thence northwards and westwards successively along the said boundary of the borough to the point of commencement aforesaid.

"The South-East Ward.

"The South-East Ward shall comprise so much of the said borough as is contained within an imaginary line commencing at a point in the eastern boundary of the borough where the Tunbridge Branch of the South-Eastern Railway Company's line crosses the said boundary thence southwards and eastwards along the boundary of the borough to the point of intersection with Salmons Cross-lane thence northwards westwards and northwards successively along the eastern boundary of the South-West Ward as hereinbefore described to Smoke-lane thence eastwards along the southern boundary of the Central Ward as hereinbefore described to the point of intersection of Upper Bridge-road and Whitepost Hill-road thence eastwards along the southern boundary of the East Ward as hereinbefore described to the point of commencement aforesaid.

"And I the said Commissioner in further pursuance of the terms of the said Warrant and for the purposes aforesaid do hereby assign and apportion all the existing Councillors among the
