IT is hereby notified for public information that all the territories in East Africa, now under the Protectorate of Her Majesty, except the Islands of Zanzibar and Pemba and the Uganda Protectorate, are for the purposes of administration included in one Protectorate, under the name of the East Africa Protectorate.

This Protectorate includes the territories bounded on the north by the River Juba, on the east by the Indian Ocean, on the south by the German sphere, on the west by the Uganda Protectorate, and also all adjacent islands between the mouths of the Rivers Juba and Umba.

ORDER of the Local Government Board: District Auditor: Assignment of District and Duties:—

North-Western Counties Audit District.

To John Frederick Adams, District Auditor;—

To the County Councils of the several Administrative Counties named in Schedule A to this Order, and to the County Council of the Administrative County of Cardigan;—

To the Visiting Committees of any Lunatic Asylums belonging wholly or in part to one or more of the said County Councils and not belonging in part to any other County Council;—

To the Local Fisheries Committee for the Western Sea Fisheries District;—

To the Guardians of the Poor of the several Unions named in Schedule B to this Order;—

To the Overseers of the Poor of the several Parishes comprised within the said Unions respectively;—

To the Authorities referred to in Article II (3), (4), and (5) of this Order;—

And to all others whom it may concern.

WHEREAS by Section 4 of the District Auditors Act, 1879, it is enacted that the Local Government Board may from time to time assign to District Auditors their Duties, and the Districts in which such Auditors respectively are to act, and may from time to time change wholly or in part such Duties or Districts;

And whereas by an Order dated the 1st day of August, 1896, We, the Local Government Board, certified the appointment of Charles Frederick Jordison as a District Auditor, and directed that, until such date as We might thereafter determine, it should be the duty of the said Charles Frederick Jordison to audit the Accounts of the Authorities referred to in Article II of this Order.

And whereas the said John Frederick Adams, hereinafter referred to as "the said District Auditor," is a District Auditor duly appointed under the provisions of the Statutes in that behalf, and is the Auditor for the North-Eastern Counties Audit District;

Now therefore, We, the Local Government

Board, hereby certify the appointment of the said District Auditor accordingly, and hereby Order and Prescribe as follows:—

ARTICLE I.—It shall, unless We otherwise Prescribe, be the duty of the said District Auditor to audit the Accounts of the following Authorities and of their Officers so far as the same relate to any period prior to the first day of April, one thousand eight hundred and ninety-six; namely,—

- (1.) The County Councils of the several Administrative Counties named in Schedule A to this Order.
- (2.) The Visiting Committee of any Lunatic Asylum belonging wholly, or in part, to one or more of the said County Councils, and not belonging in part to any other County Council.
- (3.) Any Joint Committee consisting of representatives of two or more of the said County Councils, or of representatives of one or more of the said County Councils and of other persons not being representatives of any other County Council.
- (4.) Such of the Visiting Committees of Asylums or other Joint Committees including representatives of the County Council of one or more of the said Counties and representatives of the County Council or Councils of some other County or Counties, as We may by Order under Our Seal hereafter prescribe.
- (5.) The Local Fisheries Committee for the Western Sea Fisheries District.

ARTICLE II.—It shall, unless We otherwise Prescribe, be the duty of the said District Auditor to audit the Accounts of the following Authorities and of their Officers; namely,—

- (1.) The Guardians of the Poor of the several Unions named in Schedule B to this Order.
- (2.) The Overseers of the Poor of the several parishes comprised in the said Unions.
- (3.) The Rural District Council for the Rural District of Wirrall, such District being partly within the said Audit District.
- (4.) The Joint Committee appointed to exercise the powers of a Burial Board by the Parish Councils of the Parishes of Bickerton and Broxton and the Parish Meetings of the Parishes of Bulkeley or Buckley, Duckington, Egerton, and Larkton.
- (5.) The several other Authorities for the time being whose Accounts are or may be by law subject to be audited by a District Auditor, and whose Districts or the areas of whose jurisdiction are for the time being wholly situated within one or more of the said Unions.
- (6.) Such of the other Authorities whose Accounts are or may be by law subject to be so audited, and whose Districts or the areas of whose jurisdiction are for the time being partly situated within one or more of the said Unions, as We may by Order under Our Seal hereafter prescribe.

ARTICLE III.—The said District Auditor shall audit the said Accounts according to the provisions of the several Statutes and of the Orders issued by competent authority, in force for the time being in that behalf, and shall perform all such duties and exercise all such powers in connection with the audit of such Accounts as are prescribed and conferred by the said Statutes and Orders.

ARTICLE IV.—The District in which the said District Auditor shall, on and after the date hereof, act as Auditor, and which We hereby assign to him, shall be termed the “North-Western Counties Audit District,” and shall, for

the performance of the duties assigned to him by Article I of this Order comprise the area for the time being included in the several Administrative Counties named in Schedule A to this Order, and the area comprised in the Western Sea Fisheries District; and, for the performance of the duties assigned to him by Article II of this Order, shall comprise the area for the time being included in the several Unions named in Schedule B, the District and area referred to in paragraphs (3) and (4) of the said Article II, and the Districts or areas subject to the jurisdiction of any such Authority as is mentioned in paragraph (6) of that Article.

ARTICLE V.—On and after the date of this Order, any duty imposed on Charles Frederick Jordison by the above-cited Order dated the first day of August, one thousand eight hundred and ninety-six, to audit the Accounts of any of the Authorities referred to in this Order, or their officers, shall be determined.

ARTICLE VI.—Nothing in this Order shall affect or interfere with the duties and powers of the said John Frederick Adams as District Auditor for the said North-Eastern Counties Audit District.

ARTICLE VII.—In this Order the term “Overseers of the Poor” includes Churchwardens and Assistant Overseers.
