the existing main conduit of the Board, at a point 2 chains, or thereabouts, to the west of the valve house situate at the termination of such existing main conduit, and terminating in the parish of Sutton Coldfield, in the field numbered 1211 on the  $\frac{1}{12500}$  Ordnance Map of the said parish of Sutton Coldfield, at a point 5 chains, or thereabouts, measured in a south-easterly direction from the farmstead known as Minworth Greaves, which said Conduit No. 1 will pass from, through, or into the parishes of Curdworth and Sutton Coldfield.

2. A pumping station, to be situate wholly in the hamlet or civil parish of Minworth, in the parish of Curdworth, in a field numbered 204 on the \( \frac{1}{2\frac{1}

3. A conduit or channel (to be called Conduit No. 2), commencing in the hamlet or civil parish of Minworth, in the parish of Curdworth, at or in the pumping station lastly described, and terminating in the parish of Sutton Coldfield in the field numbered 2193 on the \( \frac{1}{2500} \) Ordnance Map of the said parish of Sutton Coldfield, at a point situate at or near the north-western corner of the said field, and distant 25 chains, or thereabouts, measured in a westerly direction from the farmstead known as Wiggins Hill, which said Conduit No. 2 will pass from, through, or into the parishes of Curdworth and Sutton Coldfield.

4. An outfall conduit or channel (to be called Conduit No. 3), wholly situate in the hamlet or civil parish of Minworth, in the parish of Curdworth, commencing by a junction with a water-course situate on the western side of the field numbered 244 on the  $\frac{24}{2500}$  Ordnance Map of the portion of the said parish of Curdworth called thereon the parish of Minworth, at a point in such water-course, situate 8 chains, or thereabouts, measured in a north-westerly direction from the bridge which carries over the Birmingham and Fazeley Canal the road leading northward from Minworth Green to Hurst Green Farm. and terminating in or near to the River Tame, at a point situate at the south-eastern corner of the piece of land on which formerly stood Minworth Mill, and numbered 16 on the lastmentioned Ordnance Map.

5. An outfall conduit or channel (to be called Conduit No. 4), commencing in the parish of Sutton Coldfield by a junction with a water-course situate between two fields belonging to William Wakefield, and in the occupation of William Clement, which fields are numbered respectively 2176 and 2199 on the 2100 Ordnance Map of the parish of Sutton Coldfield, at a point in such water-course situate 19 chains, or thereabouts, measured in a north-westerly direction from the culvert carrying the said water-course beneath the Birmingham and Fazeley Canal, and terminating in the said parish of Sutton Coldfield by a junction with the intended Conduit No. 5, next hereinafter described, at or near the point of commencement thereof, which said Conduit No. 4 will pass from, through, or into the parishes of Sutton Coldfield and Curdworth.

6. An outfall conduit or channel (to be called Conduit No. 5), commencing in the parish of Sutton Coldfield in the field numbered 1168 on the \(\frac{1}{2\text{000}}\) Ordnance Map of the said parish of Sutton Coldfield, at a point near the southern boundary of such field, and situate at a distance of 33 chains, or thereabouts, measured in a westerly direction from Water Orton Bridge, and terminating in the parish of Curdworth, at or in the River Tame, at a point on the left bank thereof, situate 9 chains, or thereabouts, measured in a south-westerly direction from Sweetmore Bridge, which said Conduit No. 5 will pass from, through or into the parishes of Sutton Coldfield, Curdworth, Lea Marston, and Shustoke, or some of them.

The above-mentioned works will be situate partly upon the existing sewage farm of the Board, partly upon the lands proposed to be taken for the extension of the said farm, and hereinbefore described, and partly on the lands numbered 150, 78, 197, 197a, 189, 207, 234, 209, 276, 239, 66a, 67a, 66, 61, and 60, on the  $\frac{1}{2800}$  Ordnance Map of the portion of the parish of Curdworth called thereon the parish of Minworth, and partly on the lands numbered 2869, 2967, 2229, on the  $\frac{r_1}{2800}$  Ordnance Map of the said parish of Sutton Coldfield, and partly on the lands numbered 29, 50, 22, 21, 13, 14, 7, 6, 5, and 4, on the  $\frac{r_1}{2800}$  Ordnance Map of the said parish of Curdworth, all which lands are situate in the parishes aforesaid, in the county of Warwick.

To empower the Board to deviate in the construction of the intended works laterally and vertically to the extent to be shown on the plans to be deposited as hereinafter mentioned, or to be defined or indicated in the intended Act.

To empower the Board to purchase and take by compulsion or agreement lands, houses, and buildings within the parishes aforesaid for the purposes of the intended works and Act, and to empower the Board to acquire by compulsion or agreement rights or easements in, over, under, or connected with lands, houses and buildings. Part of the lands so proposed to be taken are or are reputed to be common or commonable lands, and are known by the name of Minworth Green, and are situate in the hamlet or civil parish of Minworth and parish of Curdworth; the quantity of such lands within the limits of deviation is 3A. 3R. Or., and the estimated quantity proposed to be taken is one rood.

To empower the Board to take and divert all streams and waters which can, or may be, intercepted or taken by the intended conduits or channels (including the stream called or known by the name of Sweetmore Brook), all which streams so proposed to be diverted and taken now flow into the River Tame, thence into the River Trent, thence into the Trent (Burton-upou-Trent and Humber) Navigation, and thence into the Humber; and to empower the Board to discharge or permit to flow into the River Tame the waters so intercepted and taken, and all effluent and other waters passing over, or through, or discharged from the existing and intended sewage farm, lands, and works of the Board.

To empower the Board within the parishes aforesaid, and for the purpose of the proposed works, and for the treatment of sewage and the drainage of the sewage farm and lands of the Board, to make, lay down, maintain, alter, and renew sewers, drains, pipes, culverts, channels, and other works, in, through, along, under, across, and over public highways, streams, canals, irrigation works, paths and railways, and to break up, cross, alter, divert, stop up (either temporarily or permanently) and interfere with any roads,
