OTICE is hereby given, pursuant to Rule 5 of the Second Charter of 12 Anne, that on the 17th day of March next, the Governors of Queen Anne's Bounty will make their annual distribution of grants to duly qualified benefices, in accordance with the Rules and Regulations prescribed by the said Charter and by Royal Sign Manuels.

The following observations apply to the distribution:—

1. The grants are usually of the capital sum of £200.

2. No grant is given except to meet a benefaction of the value of £200 or more in money, land, houses, rent-charge, or stipend. A rent-

charge or stipend of £15 per annum is considered equal to £200.

- 3. No grant can be made to any benefice -
- (a.) The net income of which from all sources exceeds £200 per annum.
- (b.) Which has not a consecrated church with district assigned.
- 4. The Governors have power to make as many as three grants in one year to the same benefice to meet three benefactions.

The rate of interest allowed on augmentation moneys is 3 per cent.

Further information and forms of application may be obtained from the Secretary. The last day for receiving applications is the 1st day of March next.
