ninth year of His Majesty King George the Third, chapter one hundred and thirty-four, of the Act of the second and third years of Your Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Your Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church called or known as the Chapel Royal, Brighton situate in North-street, in the parish of Brighton in the county of Sussex, and in the diocese of Chichester.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church called or known as the Chapel Royal'

Brighton situate as aforesaid.

"Now therefore, with the consent of the Right Reverend Ernest Roland Bishop of the said diocese of Chichester (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, te expedient that all that part of the said parish of Brighton which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church called or known as the Chapel Royal Brighton situate as aforesaid, and that the same sliould be named 'The District Chapelry of the Chapel Royal

"And with the like consent of the said Ernest Roland Bishop of the said diocese of Chichester (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church called or known as the Chapel Royal Brighton situate as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: provided always that so long as the Reverend John Julius Hannah Clerk in Holy Orders Prebendary of Chichester the present vicar or incumbent of the vicarage of the said parish of Brighton shall continue to be such vicar or incumbent all the fees which may be received in respect of such publication solemnization or performance at the said church called or known as the Chapel Royal Brighton situate as aforesaid shall be paid over by the minister thereof to th said John Julius Hannah and provided also that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of

baptism or for the registration thereof. We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in

Your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The district chapelry of the Chapel Royal

Brighton being :-

"All that part of the parish of Brighton in the county of Sussex and the diocese of Chichester wherein the present incumbent of such parish possesses the exclusive cure of souls which is bounded upon the north-west by the district of Saint Mary Magdalene Brighton in the county I this Order shall have been duly published in the

and diocese aforesaid and upon all other sides that is to say upon the south-west upon the south-east and upon the north-east by an imaginary line commencing upon the boundary which divides the said district of Saint Mary Magdalene Brighton from the parish of Brighton aforesaid at the junction of Bond-street with North-street and extending thence south-eastward along the middle of the last named street for a distance of nine chains or thereabouts to its junction with Eaststreet with Castle-square and with the roadway called or known as Pavilion-buildings and extending thence north-castward along the middle of the last-named roadway for a distance of twoand-a-quarter chains or thereabouts to the gateway forming the entrance to the Pavilion-gardens and extending thence northward and in a direct line across the said gardens for a distance of seven chains or thereabouts to the south-western angle of the public building called or known as the Corn Exchange and extending north-eastward along the north-western wall of the said public building for a distance of two chains or thereabouts to its north-eastern end upon the southwestern side of Church-street and extending thence still north-eastward and in a direct line to a point in the middle of the last-named street and extending thence south-castward along the middle of the last-named street for a distance of five chains or thereabouts to its junction with the roadway called or known as Marlborough-place and extending thence north-eastward along the middle of the last-mentioned roadway for a distance of nine chains or thereabouts to its junction with North-road and extending thence eastward across the south-eastern end of the lastnamed road for a distance of one-and-a-half chains or thereabouts to a point at the southwestern end of the roadway called or known as Gloucester-place and extending thence northeastward along the middle of the last named roadway for a distance of three chains or thereabouts to its junction with the footway or passage called or known as Blenheim-place and leading into the street or road called or known as Chelteuham-place, and extending thence north-west-ward along the middle of the said footway or passage called or known as Blenheim-place as aforesaid for a distance of four-and-a-half chains or thereabouts to its junction with the street or road called or known as Cheltenham-place as aforesaid and extending thence south-westward along the middle of the last-mentioned street or road for a distance of three-and-a-half chains or thereabouts to its junction with North-road aforesaid and extending thence north-westward along the middle of the last-named road for a distance of six chains or thereabouts to the boundary at the junction of the said last-named road with the street or roadway called or known as Kensingtongardens which boundary divides the said parish of Brighton from the district of Saint Mary Magdalene Brighton aforesaid,

"Save and except from the above described part of the parish of Brighton aforesaid all those buildings and premises situate at the junction of Church-street with Regent-street, and which are known as the Brighton National Schools."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when
