It is The Queen's pleasure that Presentations to Their Royal Highnesses at these Levees shall be considered as equivalent to Presentations to Her Majesty.

### REGULATIONS

TO DE OBSERVED AT THE QUEEN'S LEVEES TO BE HELD AT ST. JAMES'S PALACE, ON BEHALF OF HEB MAJESTY.

By Her Majesty's Command,

Gentlemen who propose to attend Her Majesty's Levees are requested to bring with them two large cards, with their names *clearly written* thereon, one to be left with The Queen's Page in attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to His Royal Highness.

#### PRESENTATIONS.

Gentlemen who propose to present others must send in writing the name of such Gentlemen to the Lord Chamberlain's Office, not later than two days previous to the Levee, in order that the Lord Chamberlain may submit the names to Her Majesty, when, if they are approved, Presentation Cards will be forwarded. Forms for the purpose can be obtained at the Lord Chamberlain's Office.

Gentlemen who wish to be presented officially should communicate with the heads of their Department, who will provide them with the necessary cards and instructions.

It is particularly requested that the names of the Gentlemen to be presented be very distinctly written on the Presentation Cards delivered to the Lord Chamberlain at the Levee, in order that there may be no difficulty in announcing them to His Royal Highness.

#### PRESENT,

The QUEEN's Most Excellent Majesty in Council.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirtyfour; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the fourth day of February, in the year one thousand eight hundred and ninety-seven, in the words following, that is to say :--

words following, that is to say :--"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fiftyninth year of His Majesty King George the Third chapter one hundred and thirty-four of the Act of the second and third years of Your Majesty chapter forty-nine and of the Act of the nineteenth and twentieth years of Your Majesty chapter fifty-five have prepared and now humbly lay before Your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church called Christ Church situate in Crendon-street in the parish of Chipping Wycombe otherwise called or known as High Wycombe in the county of Buckingham and in the diocese of Oxford.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church called Christ Church situate as aforesaid.

"Now therefore with the consent of the Right Reverend William Bishop of the said diocese of Oxford (testified by his having signed and sealed this representation) we the said Ecclesiastical Commissioners humbly represent that it would in our opinion be expedient that all that part of the said parish of Chipping Wycombe or High Wycombe which is described in the schedule hereunder written all which part together with the boundaries thereof is delineated and set forth on the map or plan hereunto annexed should be assigned as a district chapelry to the said church called Christ Charch situate as aforesaid and that the same should be named 'The District Chapelry of Christ Church High Wycombe.'

"And with the like consent of the said William Bishop of the said diocese of Oxford (testified as aforesaid) we the said Ecclesiastical Commissioners further represent that it appears to us to
