

DISEASES OF ANIMALS ACTS, 1894 AND 1896 (*continued*).

SWINE-FEVER INFECTED AREAS.

THE following Areas are now *Areas Infected with Swine-Fever* under the above-mentioned Acts :—

Bedfordshire and Buckinghamshire.—An Area comprising the parishes of Heath and Reach, Eggington, Stanbridge, Billington, and Leighton Buzzard, in the county of Bedford; and also comprising the parishes of Linslade, and Grove, in the county of Buckingham (19 February, 1897).

Berkshire.—An Area comprising the petty sessional divisions of Abingdon, and Wallingford (or Moreton), in the county of Berks, and also comprising the boroughs of Abingdon, and Wallingford (23 November, 1896).

Cambridgeshire.—An Area in the county of Cambridge comprising the parishes of Great Eversden, Little Eversden, Harlton, Comberton, Toft, Kingston, Orwell, Wimpole, and Barrington (18 January, 1897).

Derbyshire.—An Area comprising the parishes of Pleasley, and Upper Langwith, in the county of Derby (18 February, 1897).

Essex.—An Area comprising the petty sessional divisions of Tendring, Lexden and Winstree, and Witham, in the county of Essex, and also comprising the boroughs of Colchester, Harwich, and Maldon (16 November, 1896).

Gloucestershire.—(1.) An Area in the county of Gloucester comprising the parishes of Stroud, Bisley with Lippiatt, Chalford, Stonehouse, Rodborough, Kings Stanley, Leonard Stanley, Standish, Randwick, Woodchester, Whiteshill, Cainscross, Uplands, and Thrupp (26 January, 1897).

(2.) An Area comprising the parishes of Sandhurst, Norton, Boddington, Uckington, Swindon, Prestbury, Charlton Kings, Leckhampton, Up Hatherley, Badgeworth, Churchdown, Staverton, Down Hatherley, Twigworth, and Great Shurdington, in the county of Gloucester, and also comprising the borough of Cheltenham (26 January, 1897).

Huntingdonshire.—An Area comprising the parishes of Bury, and Ramsey, in the county of Huntingdon (21 April, 1896).

Kent.—An Area in the county of Kent comprising the boroughs of Margate, and Ramsgate, and the petty sessional division of Ramsgate together with the parish of Sarre and any other place which is included in the liberty of a Cinque Port and is situate within or to the north of the said division (24 November, 1896).

Lancashire.—(1.) An Area in the county of Lancaster comprising the parishes or townships of Standish-with-Langtree, Orrell, Pemberton, Winstanley, Billinge Higher End, Billinge Chapel End, Ashton-in-Makerfield, Golborne, Lowton, Haydock, Newton-in-Makerfield, Kenyon, Southworth-with-Croft, and Culcheth, and also comprising the borough of Wigan (21 December, 1896).

(2.) An Area comprising the borough of Burnley (15 March, 1897).

Lincolnshire.—An Area comprising the parishes of Sutton Bridge, Long Sutton, Little Sutton, Lutton, Gedney, Fleet, Holbeach, Whaplode, Moulton, Weston, Cowbit, Spalding, and Pinchbeck, in the Parts of Holland, Lincolnshire (14 September, 1896).

Middlesex.—An Area in the county of Middlesex comprising the township of Uxbridge, and the parishes of Hillingdon East, Hillingdon West, Cowley, Yiewsley, Hayes, Norwood, and Hanwell (except Hanwell detached) (17 November, 1896).

Norfolk.—An Area comprising the petty sessional divisions of Freebridge Marshland, and Clackclose, in the county of Norfolk (16 November, 1896).

Northamptonshire.—(1.) An Area in the county of Northampton comprising the parishes of Rushden, Finedon, Irthlingborough, Little Addington, Great Addington, Woodford, and Ringstead (14 January, 1897).

(2.) An Area comprising the parishes of Dallington, Dallington St. James, Duston, Duston St. James, Far Cotton, Kingsthorpe, and Hardingstone, in the county of Northampton, and also comprising the borough of Northampton (14 January, 1897).

Nottinghamshire.—An Area comprising the parish of Sutton-in-Ashfield in the county of Nottingham (27 February, 1897).

Staffordshire.—An Area comprising the borough of West Bromwich (15 March, 1897).

Warwickshire.—(1.) An Area comprising the parishes of St. Michael's Without, Holy Trinity Without, Stoneleigh, Stivichall, Binley, Stoke, Wyken, Foleshill, and Coundon, in the county of Warwick, and also comprising the borough of Coventry (28 September, 1896).

(2.) An Area in the county of Warwick comprising the parishes of Sutton Coldfield, Minworth, Aston Manor, Erdington, Castle Bromwich, and Water Orton (4 January, 1897).

Yorkshire.—(1.) An Area comprising the civil parishes or townships of Pontefract, Pontefract Park District, Glass Houghton, Ferry Fryston and Ferrybridge, Burtón Salmon, Byram-cum-Sutton, Purston Jaglin, Castleford, Knottingley, Brotherton, Carleton, Tanshelf, and Featherstone, in the West Riding of the county of York (28 September, 1896).

(2.) An Area comprising the civil parishes or townships of Royston, Monk Bretton, Ardsley, Worsbrough, Barugh, Darfield, Carlton, Darton, Kexbrough, Dodworth, and Wombwell, in the West Riding of the county of York, and also comprising the borough of Barnsley (28 September, 1896).

(3.) An Area in the North Riding of the county of York comprising the petty sessional divisions of Langbaugh East, and Langbaugh North, and also comprising the boroughs of Middlesbrough, and Thornaby-on-Tees (6 January, 1897).

(4.) An Area comprising the borough of Scarborough (15 February, 1897).

(5.) An Area comprising the petty sessional division of Ouse and Derwent in the East Riding of the county of York, and also comprising the borough of York (15 February, 1897).

THE following districts or areas are now *Swine-Fever Suspected Zones* under the above-mentioned Acts :—

Bedfordshire.—A district or area comprising the borough of Bedford (8 January, 1897).
