Whereas We have deemed it expedient that a Commission should forthwith issue to inquire-

(1.) Whether having regard to financial considerations and to present and prospective requirements as regards Water Supply in the Districts within the limits of supply of the Metropolitan Water Companies, it is desirable in the interests of the ratepayers and water consumers in those Districts that the Undertakings of the Water Companies should be acquired and managed either

(a.) by one authority; or

(b.) by several authorities; and if so, what should be such authority or authorities. To what extent physical severance of the works and other property and sources of supply of several Companies, and the division thereof between different local authorities within the limits of supply, are practicable and desirable; and what are the legal powers necessary to give effect to any such arrangements.

(2.) If the Undertakings are not so acquired, whether additional powers of control should be exercised by local or other authorities; and, if so, what those powers should be.

(3.) Whether it is practicable to connect any two or more of the different systems of supply now administered by the eight Metropolitan Companies; and, if so, by whom, and in what proportion should the cost of connecting them be borne, and what are the legal powers necessary to give effect to any such arrangement.

Now know ye, that We, reposing great trust and confidence in your knowledge and ability, have authorized and appointed, and do by these Presents authorize and appoint you, the said Henry, Viscount Llandaff; John William Mellor; Sir John Edward Dorington; Sir George Barclay Bruce; Alfred De Bock Porter; Alexander de Courcy Scott; Henry William Cripps; and Robert Lewis; to be Our Commissioners for the

purposes of the said inquiry.

And for the better effecting the purposes of this Our Commission, We do by these Presents give and grant unto you, or any three or more of you, full power to call before you such persons as you shall judge likely to afford you any information upon the subject of this Our Commission; and also to call for, have access to, and examine all such books, documents, registers and records as may afford you the fullest information on the the subject; and to inquire of and concerning the premises by all other lawful ways and means whatsoever.

And We do by these Presents authorize and empower you, or any three or more of you, to visit and personally inspect such places as you may deem it expedient so to inspect for the more effectual carrying out of the purposes aforesaid.

And We do by these Presents will and ordain that this Our Commission shall continue in full force and virtue; and that you Our said Commissioners, or any three or more of you, may from time to time proceed in the execution thereof, and of every matter and thing therein contained, although the same be not continued from time to time by adjournment.

And We do further ordain that you, or any three or more of you, have liberty to report your proceedings under this Our Commission from time to time, if you shall judge it expedient so to do.

And Our further will and pleasure is, that you do, with as little delay as possible, report to Us, under your hands and seals, or under the hands and seals of any three or more of you, your opinion upon the matters herein submitted for your consideration.
