The Companies Acts, 1852 to 1893.

The Mysore Reefs (Kangundy) Company Limited.

At an Extraordinary General Meeting of the above-named Company, duly convened and held at Cannon-street Hotel, in the city of London, on Monday, the 24th day of May, 1897, the following resolutions were passed, and at a subsequent Extraordinary General Meeting of the Company, also duly convened and held at the offices of the Company, No. 6, Queen-street-place, in the said city of London, on Thursday, the 10th day of June, 1897, the said resolutions were duly confirmed:—

1. "That it is desirable to reconstruct the Company, and that with a view thereto the Company be wound up voluntarily, and that Mr. John Garland, of No. 6, Queen-street-place, London, E.C., be and he is hereby appointed the Liquidator for the purpose of such winding up, at an agreed remuneration of one hundred and fifty guineas.

2. "That the said Liquidator be and he is hereby authorized to consent to the registration of a new Company to be named 'The Mysore Reefs (Kangundy), Limited,' and with a Memorandum and Articles of Association, which have been already prepared with the privity and approval of the Directors.

3. "That the draft agreement submitted to this Meeting and expressed to be made between this Company and its Liquidator of the one part and the new Company of the other part be and the same is hereby approved, and that the said Liquidator be and he is hereby authorized, pursuant to section 161 of the Companies Act of 1862, to enter into an agreement with such new Company (when incorporated) in the terms of the said draft, and to carry the same into effect with such (if any) modifications as he thinks expedient."
