ORDER of the Local Government Board: District Auditor: Assignment of District and Duties:--

South-Western Counties Audit District.

To Charles Hunton, District Auditor ;--

To the County Councils of the several Admin-

istrative Counties named in Schedule A to this Order ;---

- To the Visiting Committees of any Lunatic Asylums belonging wholly or in part to one or more of the said County Councils and not belonging in part to any other County
- the Overseers of the Poor of the Parishes of Bryher, Saint Agnes, Saint Martin's, Saint Mary's, and Tresco, which are included in the said Isles ;--
- To the Guardians of the Poor of the several Poor Law Unions named in Schedule B to this Order :---
- To the Overseers of the Poor of the several Parishes comprised within the said Unions respectively ;-
- To the Authorities referred to in Article II (3) of this Order ;--

And to all others whom it may conceru.

WHEREAS by Section 4 of the District Auditors Act, 1879, it is enacted that the Local Government Board may from time to time assign to District Auditors their Duties, and the Districts in which such Auditors respectively are to act, and may from time to time change wholly or in part such Duties or Districts;

And whereas the said Charles Hunton is a District Auditor duly appointed under the provisions of the Statutes in that behalf:

Now therefore, We, the Local Government Board, hereby certify the appointment of the said Charles Hunton as a District Auditor as aforesaid, and do Order and Prescribe as follows :---

ARTICLE I.—It shall, unless We otherwise Prescribe, be the duty of the said District Auditor to audit the Accounts of the following Authorities and of their Officers so far as the same relate to any period prior to the first day of April, one thousand eight hundred and ninety-seven; namely.—

- namely,— (1.) The County Councils of the several Administrative Counties named in Schedule A to this Order.
 - (2.) The Visiting Committee of any Lunatic Asylum belonging wholly, or in part, to one or more of the said County Councils, and not belonging in part to any other County Council.
 - (3.) The Council of the Isles of Scilly, and the Overseers of the Poor of the Parishes of
 - Bryher, Saint Agnes, Saint Martin's, Saint Mary's, and Tresco, which are included in the said Isles.
 - (4.) Any Joint Committee consisting of representatives of two or more of the said County Councils, or of representatives of one or more of the said County Councils and of other persons not being representatives of any other County Council.

(5.) Such of the Visiting Committees of Asylums or Joint Committees including representatives of the County Council of one or more of the said Counties and representatives of the County Council or Councils of some other County or Councils, as We may by Order under Our Seal hereafter prescribe.

ARTICLE II.—It shall, unless We otherwise prescribe, be the duty of the said District Auditor to audit the Accounts of the following Authorities and of their Officers; namely,—

- (1.) The Guardians of the Poor of the several Poor Law Unions named in Schedule B to this Order.
- (2.) The Overseers of the Poor of the several Parishes comprised in the said Unions.
- (3.) The several other Authorities for the time being whose Accounts are cr may be by law subject to be audited by a District Auditor, and whose Districts or the areas of whose jurisdiction are for the time being wholly situated within one or more of the said Unions.
- (4.) Such of the other Authorities whose Accounts are or may be by law subject to be so audited, and whose Districts or the areas of whose jurisdiction are for the time being partly situated within one or more of the said Unions, as We may by Order under Our Seal hereafter prescribe.

ARTICLE III.—The said District Auditor shall audit the said Accounts according to the provisions of the several Statutes and of the Orders issued by competent authority, in force for the time being in that behalf, and shall perform all such duties and exercise all such powers in connection with the audit of such Accounts as are prescribed and conferred by the said Statutes and Orders.

AETICLE IV.—The District in which the said Charles Hunton shall act as Auditor, and which shall be termed the "South-Western Counties Audit District," shall, for the performance of the duties assigned to him by Article I of this Order, comprise the area for the time being included in the several Administrative Counties named in Schedule A to this Order, and in the Isles of Scilly; and, for the performance of the duties assigned to him by Article II of this Order, shall comprise the area for the time being included in the several Unions named in Schedule B to this Order and the Districts or areas subject to the jurisdiction of any such Authority as is mentioned in paragraph (4) of the said Article II.

ARTICLE V.—Any Order in force at the date of this Order assigning a District to the said Charles Hunton for the discharge of his duties as District Auditor is hereby rescinded, but nothing in this Order shall affect or interfere with the duties and powers of the said Charles Hunton, or of any Assistant District Auditor, as regards the audit of the Accounts of the Council of the Administrative County of Southampton for any period prior to the first day of April, one thousand eight hundred and ninety-seven, or as regards any. Audit which, before the issue of this Order, may have been commenced or held by either of them; or of which either of them may have given notice, or as regards any proceedings arising out of any such Audit.

ARTICLE VJ.-In this Order-

The term "Overseers of the Poor" includes Churchwardens and Assistant Overseers.
