RADNORSHIRE (MUZZLING OF DOGS) AMEND-MENT ORDER OF 1897.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Extension of District to which the Radnorshire (Muzzling of Dogs) Order of 1897 applies.

1. From and after the commencement of this Order the provisions of the Radnorshire (Muzzling of Dogs) Order of 1897 shall apply to and be in force in the part of a District of a Local Authority mentioned in the Schedule to this Order, and shall be enforced by the Local Authority of such District.

Commencement.

2. This Order shall come into operation on the thirteenth day of July, one thousand eight hundred and ninety-seven.

Short Title.

3. This Order may be cited as the RADNOR-SHIRE (MUZZLING OF DOGS) AMENDMENT ORDER of 1897.

1. The following Place (namely),—the cowsheds and yard at 25A, Norfolk-street, Globeroad, in the county of London, in the occupation of Evan Lloyd,—which was declared by Order of the Board dated the fourteenth day of June, one thousand eight hundred and ninety-seven to be a Place infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Place shall, as from the commencement of this Order, cease to be a Place infected with pleuro-pneumonia.

2. This Order shall come into operation on the first day of July, one thousand eight hundred and
