through the mouth of the Psalmist, "I will deliver him and bring him to honour," "with long life will I satisfy him, and will show him My salvation" (Psalm xci, 16): and we pray that as it has been in Your Majesty's life so it may be in that of our kings and queens "to be," that length of days may be asked for and received, only as lengthened opportunities of service to the King of Kings, and that the life on earth may blend into that which is promised as the reward of faithfulness to earthly trusts - " the King asked life of Thee, and Thou gavest him a long life, even for ever and ever" (Psalm xxi, 4).
