To Our dear Grandson and Councillor George Frederick Ernest Albert, Duke of York, Knight of the Most Noble Order of the Garter, Knight of the Most Ancient and Most Noble Order of the Thistle,

Whereas by the Patriotic Fund Act of 1881, it was, among other things, enacted that "it should be lawful for Her Majesty, from time to time, by Warrant under Her Sign Manual, to appoint any person to fill any vacancy among the Commissioners of the Patriotic Fund which has arisen, either before or after the passing of this Act, from death, resignation, or otherwise."

(PLEURO-PNEUMONIA INFECTED PLACE.)

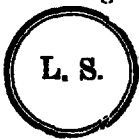
THE Board of Agriculture, by virtue and in

exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The following Place (namely),—the cowsheds and other buildings used for cattle at 42, Jubilee-street, Mile End, in the county of London, in the occupation of William Cave,—which was declared by Order of the Board dated the twelfth day of July, one thousand eight hundred and ninety-seven to be a Place infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Place shall, as from the commencement of this Order, cease to be a Place infected with pleuro-pneumonia.

2. This Order shall come into operation on the second day of September, one thousand eight hundred and ninety-seven.

Alterations in Lights.

(eastward of North Klakken); fixed white from S. 27° E., through south, to S. 36° W.; flashing light from S. 36° W. (westward of Terningen and Kolbeinsflua) to S. 47° W.; fixed white from S. 47° W., through west, to N. 87° W., and obscured from other directions.

Approximate position, lat. 62° 53' 45" N., long. 6° 49' 25" E.

2. Tyrhaug light was altered to show the following sectors:—Flashing light from N. 72° E. to N. 68° E. (southward of Edöskagen); fixed white from N. 68° E., through north and west, to S. 83° W.; flashing light from S. 83° W. to S. 73° W. (over Grisvaegskjaerene and Friskjaer); fixed white from S. 73° W. to S. 53° W.; red from S. 53° W. (eastward of Ramsögalten) to S. 7° W.; and obscured from other directions.

Approximate position, lat. 63° 18' 40" N., long. 8° 14' 5" E.

Dangers Eastward of Sir James Hall Group.

INFORMATION has been received from the Japanese Government of the existence of the undermentioned dangers:—

1. A rock, which dries at low water, was seen about three-quarters of a mile northward of Three Rocks, westward of Kerrin Do.

Approximate position, lat. 37° 49½' N., long. 124° 56¾' E.

2. Rocks, which dry at low water, extend nearly one mile, N.W. by W. ½ W., from the point on the mainland, in approximately lat. 37° 59' 10" N., long. 125° 3' 20" E.

3. A rock, about a quarter of a cable in extent, which dries at low water neaps, is situated about half a mile north-eastward of the above point.

River São Francisco (Do-sul)—Amended Particulars of Shoals South-Eastward of Ovaringa Island.

INFORMATION has been received from Commander E. P. Ashe, Her Majesty's ship "Basilisk," dated 27th July, 1897, of the under-mentioned particulars of the shoals south-eastward of Ovaringa Island, now marked "P.D." on the Chart:—

1. A rocky shoal, with a least depth of 2 fathoms on it, is situated with São Francisco Church bearing S. 10° W., distant 14½ cables; and Peroba Point S. 77° E.

A black buoy, surmounted by a topmark, is moored on the northern side of this shoal.

Approximate position, lat. 26° 13' 10" S., long. 48° 38' 30" W.

2. A rocky shoal, with a least depth of 2 fathoms on it, is situated with São Francisco Church bearing S. 18° W. distance one mile; and Peroba Point N. 84° E.

A red buoy marks the northern side of this shoal.

The rock marked "P.D.," with buoy, shown on the chart a quarter of a mile N.N.E. of position of rocky shoal (1); and the three rocks, with buoy, extending a quarter of a mile N.E. from position of rocky shoal (2); have been expunged from the charts.

No. 514.—ENGLAND—BRISTOL CHANNEL.

Intended Alterations in Sectors of Burnham (Bridgewater) Lights.

THE Trinity House, London, has given notice that, on 15th September, 1897, the under-mentioned alterations will be made in the arcs of visibility of Burnham (Bridgewater) lights:—

1. Burnham lower light (fixed) will show white from S. 54° E. to S. 85° E.; and red from S. 85° E. to East.

2. Burnham upper light (occluding white) will be visible from S. 24° E. to S. 86° E.
