ORDER OF THE BOARD OF AGRICULTURE.

(DATED 17TH NOVEMBER 1897.)

SWINE - FEVER (MOVEMENT FROM IRELAND) TEMPORARY ORDER OF 1897 (No. 4):

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

Swine-Fever (Movement from Ireland) Temporary Order of 1894 continued until 30th November 1898.

1. The Swine-Fever (Movement from Ireland) Temporary Order of 1894 shall be read and have effect as if the thirtieth day of November, one thousand eight hundred and ninety-eight were substituted for the thirtieth day of November, one thousand eight hundred and ninety-four in Article 1 of that Order, as the date from and immediately after which that Order shall cease to operate, and the operation of that Order which was continued by subsequent Orders is hereby further continued accordingly.

Existing Regulations of Local Authority.

2. Any Regulation made by a Local Authority under the Swine-Fever (Movement from Ireland) Temporary Order of 1894 as continued by subsequent Orders and in force on the thirtieth day of November, one thousand eight hundred and ninety-seven, shall, unless altered or revoked by such Local Authority, remain in force until the
