WE, the undersigned, being two of the Lords Commissioners of Her Majesty's Treasury of the United Kingdom of Great Britain and Ireland, do hereby under the authority of "The Customs Consolidation Act, 1876," appoint Whitehaven to continue and be a Port in that part of the United Kingdom called England, and we do hereby declare that the limits of the said Port shall commence at mid-stream of the River Esk where it is crossed by the Eskmeals Viaduct of the Furness Railway, thence along the midstream of the said river on the east side thereof to a spot north of the north point of Eskmeals, thence along mid-channel of the estuary of the Esk and along the sea coast to a stream called Loura Brck, which stream separates the parishes of Moresby and Harrington; and also that the limits of the said Port shall extend to a distance of three miles from low water mark out to sea, and include all islands, rivers, bays, roads, harbours, creeks, streams, waters, watercourses, channels, havens, and places within the same respectively; and we do hereby annul all former limits of the said Port of Whitehaven.

BARROW-IN-FURNESS. LIMITS OF PORT.
