

the present regulation or assisting in any way in the commission of such breach and the Master, Captain or other person having the control of any vessel or boat, on board of which such breach has been committed or which has been in any way engaged in the commission of such breach, shall be severally liable to a fine not exceeding £100, or to imprisonment not exceeding three months, or to both such punishments.

10. Any cost incurred by the Siamese Government, in the maintenance of any person removed to the Quarantine Station at Koh Phai, shall be repaid by the agents of the vessel.
