

"And with the like consent of the said Edward Stuart, Bishop of the said diocese of Rochester (testified as aforesaid) we, the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint Michael and All Angels situate as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Michael and All Angels Southfields, Wandsworth, being all that part of the parish of All Saints, Wandsworth, in the county of Surrey and in the diocese of Rochester, which is bounded upon the east by the parish of Saint Anne, Wandsworth, or in other words by the main stream of the River Wandle, upon the south-east and upon the south by the new parish of Saint Paul, Wimbledon Park, Wandsworth, both in the county and diocese aforesaid, and upon the remaining sides, that is to say, upon the west, upon the north-west, and upon the north by an imaginary line commencing upon the boundary which divides the said new parish of Saint Paul, Wimbledon Park, Wandsworth, from the parish of All Saints, Wandsworth aforesaid, at the junction of Augustus-road with Sutherland-road and extending thence northward along the middle of the last-named road for a distance of 43 chains or thereabouts to its junction with Cromer Villas-road, and extending thence north-eastward along the middle of the last-named road for a distance of twelve chains or thereabouts to its junction with Viewfield-road and with West Hill-road and extending thence first eastward and then south-eastward along the middle of the last-named road for a distance of twenty-one chains or thereabouts to its intersection by Wimbledon Park-road, and extending thence north-eastward along the middle of the last-named road for a distance of ten chains or thereabouts to its junction with Merton-road and extending thence first northward and then north-eastward along the middle of the last-named road for a distance of twenty-two chains or thereabouts to its junction with the road called West Hill and with Broomhill-road upon the boundary which divides the said parish of All Saints, Wandsworth, from the new parish of Saint Stephen, Wandsworth, in the county and diocese aforesaid, and extending thence southward along the middle of the last-named road for a distance of fourteen chains or thereabouts to its junction with Buckhold-road and extending thence first north-eastward and then eastward along the middle of the last-named road for a distance of fourteen chains or thereabouts to the boundary at the main stream of the River Wandle aforesaid which boundary divides the said parish of All Saints,

Wandsworth, from the parish of Saint Anne, Wandsworth aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: now therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Rochester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the seventh and eighth years of Her Majesty chapter ninety-four, of the Act of the thirteenth and fourteenth years of Her Majesty chapter ninety-four, and of the Act of the thirty-second and thirty-third years of Her Majesty chapter ninety-four, duly prepared and laid before Her Majesty in Council a scheme or representation bearing date the twenty-sixth day of May, in the year one thousand eight hundred and ninety-eight, in the words following, that is to say:—

"We the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the seventh and eighth years of Your Majesty chapter ninety-four of the Act of the thirteenth and fourteenth years of Your Majesty chapter ninety-four and of the Act of the thirty-second and thirty-third years of Your Majesty chapter ninety-four, have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Saint Paul, Sculcoates, and of the new parish of Saint Silas, Sculcoates, both in the city and county of Kingston-upon-Hull and in the diocese of York.

"Whereas by the authority of an Order of Your Majesty in Council bearing date the nineteenth day of June in the year one thousand eight hundred and forty-four and published in the London Gazette upon the tenth day of July following a part of the parish of Sculcoates then described as being in the borough of Kingston-upon-Hull in the East Riding of the county and in the diocese of York was constituted a separate district for spiritual purposes and the same was called 'The District of Saint Paul Sculcoates.'

"And whereas the said district of Saint Paul, Sculcoates, has under the provisions of the Act of the sixth and seventh years of Your Majesty chapter thirty-seven become a new parish of the character contemplated by that Act and by the above-mentioned Act of the thirty-second and thirty-third years of Your Majesty chapter ninety-four.

"And whereas by the authority of another Order of Your Majesty in Council bearing date the sixteenth day of May in the year one thousand eight hundred and seventy-one and published in the London Gazette on the nineteenth day of the same month, a part of the said new parish of Saint Paul, Sculcoates, then described as being in the town and county of the town of Kingston-upon-Hull and in the diocese of York aforesaid was assigned as a district chapelry to the con-
