a sum of four thousand three hundred pounds ! sterling in aid of the endowment of the district hereinaster recommended to be constituted and so soon as the said district shall have become a new parish under the provisions of the secondly hereinbefore mentioned Act then of the said new parish and of the maintenance of the minister or incumbent thereof for the time being and we have in respect of such sum agreed and have undertaken to provide and pay by equal half-yearly payments on the first day of May and on the first day of November in each and every year to such minister or incumbent as aforesaid when duly licensed in accordance with the provisions of the said secondly hereinbefore mentioned Act the sum of one hundred and twenty-nine pounds per annum so long as the said capital sum shall remain in our hands.

"And whereas the said capital sum of four thousand three hundred pounds sterling has been so contributed and paid as aforesaid upon the understanding and condition that we should grant out of the common fund created by the firstly herein named Act a capital sum of seven hundred pounds in respect of which there shall be paid by us to the minister or incumbent for the time being of the said proposed district or new parish when duly licensed as before mentioned a yearly sum of twenty-one pounds and upon the further understanding and condition that (such arrangement appearing to us to be expedient) we should recommend and propose to Your Majesty in Council that the whole right of patronage of the said district or new parish and of the nomination of the minister or incumbent thereof should be assigned in the manner hereinafter set forth.

"And whereas the said Frank Johnstone Mitchell the donor of the said endowment of four thousand three hundred pounds has nominated to us as the person in whom he desires that the whole right of patronage of the said proposed district or new parish and of the nomination of the minister or incumbent thereof should be vested viz.:-the Venerable William Conybeare Bruce Archdeacon of Monmouth and Vicar of the said parish of Saint Woolos Newport for the first turn only and the Right Reverend Richard now Bishop of the said diocese of Llandaff, the Reverend Thomas Thellusson Carter, Canon of Christ Church Oxford and Warden of the House of Mercy Clewer in the county of Berks, the said Frank Johnstone Mitchell, Alfred Clarke Jones of the Caks Newport in the said county of Monmonth Esquire one of Your Majesty's Justices of the Peace and George Rawlings Martyn of Skelmorlie, Newport aforesaid Esquire their heirs and assigns for the second and every succeeding turn of patronage and nomination.

"And whereas the said grant of a capital sum of seven hundred pounds will after the publication in the London Gazette of an Order of Your Majesty in Council ratifying this scheme be made and secured by an instrument to be executed by us the said Commissioners under our common seal in accordance with the provisions of the Act of the twenty-ninth and thirtieth years of Your Majesty chapter one hundred and eleven.

" Now therefore with the consent of the said Richard Bishop of the diocese of Llandaff aforesaid (in testimony whereof he has signed and sealed this scheme) we the said Ecclesiastical Commissioners. humbly recommend and propose that all those portions of the said parish of Saint Wooles, Newport, and of the said new parish of Saint Mark, Newport, which are described in the Schedule hereunder written all which portions together with the boundaries thereof are delineated and is bounded upon the south and upon the east by

set forth on the map or plan hereunto annexed shall upon and from the day of the date of the publication in the London Gazette of an Order of Your Majesty in Council ratifying this scheme as aforesaid become and be constituted a separate district for spiritual purposes and that the same should be called 'The District of Saint John the

Baptist Newport.'

"And we further recommend and propose that the whole right of patronage of the said district so recommended to be constituted and when such district shall have become a new parish as aforesaid then of the said new parish and of the nomination of the minister or incumbent thereof shall without any assurance in the law other than this scheme and a duly gazetted Order of Your Majesty in Council ratifying the same and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid be assigned to and be vested in and shall be exercised for the first turn only by the said William Conybeare Bruce and for the second and every succeeding turn jointly by the said Richard Bishop of the said diocese of Llandaff the said Thomas Thellusson Carter the said Frank Johnstone Mitchell the said Alfred Clarke Jones and the said George Rawlings Martyn their heirs and assigns for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.

"The SCHEDULE to which the foregoing scheme has reference.

"The District of Saint John the Baptist Newport comprising:-

"I. All that portion of the parish of Saint Woolos Newport in the county of Monmouth and in the diocese of Llandaff which is bounded upon the west by the parish of Bassaleg upon the north by the new parish (some-time district chapelry) of Saint Mark Newport (including the hereinafter described portion thercof) both in the said county and diocese and upon the remaining sides that is to say upon the north-east upon the cast and upon the south-east by an imaginary line commencing upon the boundary which divides the said new parish of Saint Mark Newport from the parish of Saint Woolos Newport aforesaid at the junction of Bryngwyn-road with the proposed road intended to be called Burleigh-road and extending thence south-eastward along the middle of the intended course of the said proposed road for a distance of six chains or thereabouts to its junction with Llanthewy-road and extending thence northcastward along the middle of the last-named road for a distance of six chains and three quarters or thereabouts to its junction with Spencer-road and extending thence south-eastward along the middle of the last-named road for a distance of five chains and a half or thereabouts to its junction with Caerau-road and extending thence southward along the middle of the last-named road for a distance of nine chains or thereabouts to its junction with Bassaleg-road and extending thence first westward and then generally south-westward along the middle of the last-named road for a distance of one mile and fifteen chains or thereabouts to the boundary which divides the said parish of Saint Woolos Newport from the parish of Bassaleg aforesaid.

"II. And also all that contiguous portion of the said new parish of Saint Mark Newport which
