PRESENT,

The QUEEN'S Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixth and seventh years of Her Majesty, chapter thirty-seven, and of the Act of the fifty-third and fifty-fourth years of Her Majesty, chapter one hundred and twenty-three, duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-sixth day of May, in the year one thousand eight hundred and ninety-eight, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the sixth and seventh years of Your Majesty chapter thirty-seven and of the fifty-third and fifty-fourth years of Your Majesty chapter one hundred and twenty-three, hereinafter called 'The Burnley Rectory Act 1890,' have prepared and now humbly lay before Your Majesty in Council the following scheme for constituting a separate district for spiritual purposes to be taken partly out of the new parish (sometime district chapelry) of Saint

Andrew, Burnley, in the county of Lancaster and in the diocese of Manchester and partly out of the parochial chapelry of Burnley in the same county and diocese.

"Whereas it has been made to appear to us that it would promote the interests of religion that those particular portions of the said new parish of Saint Andrew, Burnley, and of the said parochial chapelry of Burnley which are herein-after mentioned and described, should be constituted a separate district in manner hereinafter recommended and proposed.

"And whereas we are satisfied that such new parish and such parochial chapelry are cures wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the inhabitants thereof.

"And whereas there is not at present within the limits of the said proposed district any consecrated church or chapel in use for the purposes of Divine worship.

"And whereas by a deed bearing date on or about the twenty-fourth day of February in the year one thousand eight hundred and ninety-eight and being under the hand and seal of the Reverend Canon Arthur Townley Parker, the rector of the rectory of the said parochial chapelry of Burnley, under the common seal of us the said Ecclesiastical Commissioners for England and under the hand and episcopal seal of the Right Reverend James, Bishop of the said diocese of Manchester, the said Arthur Townley Parker, in pursuance of the powers and provisions of the New Parishes Acts and of 'The Burnley Rectory Act 1890' did grant and confirm unto the minister of the district herein proposed to be constituted when duly licensed thereto, and his successors and when the said proposed district shall have become a new parish then to the incumbent thereof and his successors, one perpetual clear yearly rent charge or net annual sum of one hundred and fifty pounds, to be payable half-yearly on the twentieth day of May and the twentieth day of November in each and every year and to be for ever issuing and payable out of and charged upon a certain perpetual clear annual rent charge of three hundred and eleven pounds eleven shillings and sixpence created by an indenture of conveyance dated the first day of March in the year one thousand eight hundred and forty-seven the said last-mentioned rent charge forming part of the endowments of the rectory of Burnley aforesaid.

"And whereas the whole right of patronage of the said proposed district or new parish, will, under the provisions of the eighth section of the said 'Burnley Rectory Act 1890,' be vested in and exercised by the rector of Burnley for the time being.

"Now therefore with the consent of the said James, Bishop of the said diocese of Manchester (in testimony whereof he has signed and sealed this scheme), we the said Ecclesiastical Commissioners humbly recommend and propose that all those portions of the said new parish of Saint Andrew, Burnley, and of the said parochial chapelry of Burnley which are described in the schedule hereunder written, all which portions together with the boundaries thereof are delineated and set forth on the map or plan hereunto annexed shall upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme become and be constituted a separate district for spiritual purposes and that the same shall be named 'The District of Saint Margaret, Burnley.'

"And we further recommend and propose that nothing herein contained shall prevent us
