from recommending and proposing any other measures relating to the matters aforesaid or to any of them in accordance with the provisions of the said Acts or of either of them or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Margaret, Burnley,

comprising :-

"1. All that portion of the new parish (sometime district chapelry) of Saint Andrew, Burnley, in the county of Lancaster and in the diocese of Manchester which is bounded upon the north partly by the new parish of Saint Luke, Brierfield, and partly by the new parish of Saint Ann, Fence, both in the said county and diocese upon the north-west by the last-named new parish, upon the south-west partly by the new parish of All Saints, Habergham, in the said county and diocese upon the remaining part of the southwest and upon the west by the parochial chapelry of Burnley (including the hereinafter described portion thereof) in the county and diocese aforesaid, and upon the remaining sides that is to say, upon the south-east, upon the east, and upon the north-east, by an imaginary line commencing upon the boundary which divides the said parochial chapelry of Burnley from the new parish of Saint Andrew, Burnley aforesaid, at the centre of the bridge which carries Danes House-road over the Leeds and Liverpool Canal and extending thence north-eastward along the middle of the said road for a distance of twelve chains or thereabouts to its junction with Hebrew-road and extending thence first northward and then north-eastward along the middle of the last-named road for a distance of seven chains or thereabouts to its junction with Robinson-street and extending thence northward along the middle of the lastnamed street for a distance of eighteen chains or thereabouts to its junction with New Hall-street, and extending thence eastward along the middle of the last-named street for a distance of twelve chains or thereabouts to its junction with Byerdenlane and extending thence generally north-west-ward along the middle of the last-named lane for a distance of sixty-one chains or thereabouts to the boundary which divides the said new parish of Saint Andrew, Burnley, from the new parish of Saint Luke, Brierfield aforesaid.

"2. And also all that contiguous portion of the said parochial chapelry of Burnley which is bounded upon the north-east and upon the east by the hereinbefore described portion of the said new parish of Saint Andrew, Burnley, and upon the remaining sides that is to say upon the southeast, upon the south-west and upon the northwest by an imaginary line commencing upon the boundary which divides the said new parish of Saint Andrew, Burnley, from the parochial chapelry of Burnley aforesaid at the centre of the said bridge which carries Danes House-road over the Leeds and Liverpool Canal as aforesaid and extending thence south-westward along the middle of the last-named road for a distance of five chains or thereabouts to the centre of Danes House Railway Bridge over the Clifton Accrington and Colne Line of the Lancashire and Yorkshire Railway which bridge connects the lastnamed road with Brougham-street upon the boundary which divides the said parochial chapelry of Burnley from the new parish of Saint James Burnley in the county and diocese aforesaid, and extending thence first south-westward and then north-westward along the last-mentioned boundary (thereby following first the middle of Broughamstreet aforesaid and then the middle of Canning-

street) to the point at the present north-western end of the last-named street where such street is intersected by the tramway which leads from Clifton Pit under the said Clifton Accrington and Colne Line of the Lancashire and Yorkshire Railway to Bank Hall Sidings and extending thence north-eastward along the middle of the said tramway for a distance of twenty-three chains or thereabouts to the centre of the bridge which carries the said line of railway over the said tramway and extending thence northward along the middle of the said line of railway for a distance of thirty-six chains or thereabouts to the centre of the bridge which carries such line of railway over the Leeds and Liverpool Canal upon the boundary which divides the said parochial chapelry of Burnley from the hereinbefore described portion of the new parish of Saint Andrew, Burnley aforesaid."

And whereas drafts of the said scheme have, in accordance with the provisions of the firstly hereinbefore-mentioned Act, been transmitted to the patrons and to the incumbents of the cures out of which it is intended that the district recommended in such scheme to be constituted shall be taken, and such patrons and incumbents have respectively signified their assent to such scheme:

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Manchester.
