moneys received by or on account of the said house and 1 remises and the appurtenances thereto belonging or of any part there. f shall be by him the said Bishop paid over to us the said Ecclesiastical Commissioners, and shall be held by us and be applied by the said Bishop for the purposes and in the manner next hereinafter mentioned, but with and subject to our approval, and at such times and in such manner as shall appear to us to be expedient, that is to say, firstly, in defraying all costs, charges, and expenses of and incident to the sale of the said residence known as number Berkeley - square, Bristol, and secondly 20 in defraying the cost of providing in such manner and at such times as shall be approved by us the said Ecclesiastical Commissioners another episcopal residence with the appurtenances thereto which shall be within or near to the city of Bristol aforesaid.

"And we further recommend and propose that as soon as the above mentioned new Episcopal residence shall have been provided the said George Forrest, Bishop of Bristol, or his successors, shall at his or their personal charge and expense, insure and keep insured from loss or damage by fire the same residence with the outbuildings and appurtenances such insurance being effected in one of the public offices of assurance in London or Westminster for such a sum (not being less than the sum which may be certified by the Ecclesiastical Commissioners' Surveyors as the probable cost of entirely rebuilding the same in case of fire) as may be determined by us the said Ecclesiastical Commissioners and that such Bishop shall within fourteen days after any premium for such insurance shall have become payable deliver to us the receipt for the same, and that in case of any loss or damage by fire to the said residence any and every sum of money receivable under such insurance shall become and be payable and Le paid to and deposited with us in trust to be applied and we recommend and propose that the same together with any interest and accumulations thereof shall be applied by us towards the rebuilding or repairing and reinstating of the said residence or any part thereof which may have so suffered loss and damage in such manner as shall be determined on by us with the concurrence of the said Bishop of Bristol for the time being.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in conformity with the provisions of the said Acts, or either of them or of any other Act or Acts of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said dioces of Bristol. HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the ninetcenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the seventh day of July, in the year one thousand eight hundred and ninety-eight, in the words following, that is to say:-

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fiftyninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Your Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Your Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Augustine situate in Stanford-avenue, Preston Park in the parish of Preston in the county of Sussex and in the diocese of Chichester.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Augustine situate as aforesaid.

"Now therefore, with the consent of the Right Reverend Ernest Roland Bishop of the said diocese of Chichester (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said parish of Preston which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Augustine situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Augustine, Preston, Brighton.'

"And with the like consent of the said Ernest Roland Bishop of the said diocese of Chichester (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint Augustine situate as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal wisdom, shall seem meet.
