BY an Order of Mr. Justice Wright in the above matter dated the 8th day of July 1898 on the petition of Dorman Long and Co. of the Britannia Iron Works Middlesborough in the county of York creditors of the above named Company that an Order might be made that the above named Company be wound up by Order of the Companies Acts of 1862 to 1890.
