BY virtue of an Act passed in the twentyfourth year of the reign of His Majesty King George III, intituled "An Act to repeal so "much of two Acts made in the tenth and "fifteenth years of the reign of His present "Majesty, as authorizes the Speaker of the "House of Commons to issue his Warrant to "the Clerk of the Crown for making out writs "for the election of Members to serve in Par-"liament, in the manner therein mentioned, and "for substituting other provisions for the like "purposes;" and of an Act passed in the twentysixth year of the reign of Her present Majesty, intituled "An Act to further limit and define "the time for proceeding to Election during the "Recess :"

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, the following copy of a notice respecting quarantine issued by Her Majesty's Envoy Extraordinary and Minister Plenipotentiary in Japan, viz.:--

NOTIFICATION.

THE undersigned Her Britannic Majesty's Envoy Extraordinary and Minister Plenipotentiary in Japan hereby makes known to British subjects resident in or resorting to Japan that owing to the prevalence of the plague in Formosa the Japanese Government deem it necessary that medical inspection in accordance with the Imperial Ordinance, No. 56 of May, 1894, be enforced from this day at the Port of Yokohama, Kanagawa Prefecture, against all vessels arriving direct from Formosa or which have come from that Island via Ports, and they have therefore issued a Notification to the effect that—

Vessels liable to medical inspection proceeding to the Port of Yokohama shall stop at Nagahama, Kanagawa Prefecture, and there undergo the examination of the quarantine officers.

British subjects are hereby required to conform to the above Regulations.
