THE Queen has been pleased to direct Letters Patent to be passed under the Great Seal of the United Kingdom of Great Britain and Ireland, granting the dignity of a Baron of the said United Kingdom unto Major-General Sir Horatio Herbert Kitchener, K.C.B., K.C.M.G., R.E., Sirdar of the Egyptian Army, and the heirs male of his body lawfully begotten, by the name, style, and title of Baron Kitchener of Khartoum, and of Aspall in the county of Suffolk.
