

local authority, or any company, bodies, or persons, whether within or beyond the limits of supply, on the other hand, to enter into and fulfil contracts and agreements for the supply by the Company of water in bulk, or otherwise, and to vary or extinguish any such contracts or agreements, and to confer all necessary powers on that behalf upon all such authorities, companies, bodies, and persons, and to enable them to raise and apply for the purposes of such contracts or agreements all necessary capital, and to levy the necessary rates.

11. The intended Act will or may make provision for the sale of the undertaking to the local authorities within the limits of supply, and for the purchase of the same by the local authorities, by agreement or otherwise, at such period, and upon such terms and conditions, pecuniary or otherwise, as may be previously agreed upon, or prescribed by the intended Act.

12. The intended Act will vary or extinguish all existing rights and privileges which would interfere with any of the purposes thereof, and will confer upon the Company all such other rights and privileges as may be necessary for such purposes, and will incorporate, with or without alteration, all or some of the provisions of the Lands Clauses Acts, the Companies Clauses Acts, 1845, 1863, and 1869, the Waterworks Clauses Acts, 1847 and 1863, and such portion of the Railways Clauses Consolidation Act, 1845, as relates to roads and the temporary occupation of lands.

13. Plans and sections showing the lines, situation, and levels of the intended works, and the lands and other property which may be taken under the powers of the intended Act, together with a book of reference to such plans containing the names of the owners and lessees, or reputed owners and lessees, and of the occupiers of such lands and other property, and a copy of this Notice as published in the London Gazette will, on or before the 30th day of November instant, be deposited for public inspection with the Clerk of the Peace for the county of Northampton at his office at Northampton, and on or before the same day, a copy of so much of the said plans, sections, and Book of Reference as relates to the parish of Little Addington and the Finedon Urban District respectively together with a copy of this Notice will be deposited with the Clerk of the Rural District Council of Thrapston, in respect of the parish of Little Addington, at his office at Thrapston, and with the Clerk of the Urban District Council of Finedon at his office at Wellingborough.

14. Printed copies of the Bill will be deposited in the Private Bill Office, House of Commons, on or before the 21st day of December next.

Glastonbury Water.

(Construction of Waterworks; Acquisition of Lands; Interference with Lands, Springs, Streams, Rivers, Roads, and other Property; Power to Supply Water and Levy Rates, Rents, and Charges; Prevention of Waste; Regulations; Supply in Bulk; Borrowing Powers; Incorporation of Acts, &c.)

NOTICE is hereby given that the Mayor, Aldermen, and Burgesses of the Borough of Glastonbury, in the county of Somerset (in this notice called "the Corporation") intend to

apply to Parliament in the next Session for leave to bring in a Bill for the following, or some of the following purposes; that is to say:—

To empower the Corporation to make and maintain the following waterworks and other works, or some of them, or some part or parts thereof, wholly in the county of Somerset, namely:—

Work No. 1.—A well or covered tank, situate in the parish of Pilton, in plantation or enclosure numbered 952 on the 1-2500th Ordnance map for the said parish of Pilton, at a point 15 yards or thereabouts, measured in a straight line, in a north-westerly direction from the south-easterly corner of the said plantation or enclosure.

Work No. 2.—A conduit, or line of pipes (No. 1), commencing in the parish of Pilton at the above described well or covered tank, and terminating in the parish of North Wootton in field numbered 549 on the 1-2500th Ordnance map of the said parish of North Wootton, at a point 67 yards or thereabouts, measured in a straight line, in an easterly direction from the westerly corner of the said field.

Work No. 3.—A conduit, or line of pipes (No. 2), commencing in the parish of North Wootton at the termination of line of pipes No. 1, and passing through the parishes of North Wootton and West Pennard, and terminating in the parish of Glastonbury in the existing reservoir known as Edgarley reservoir, belonging to the Corporation of Glastonbury, at or near its westerly corner.

Together with all proper embankments, bridges, roads, ways, walls, tanks, basins, gauges, filters, and filter beds, dams, sluices, hatch-boxes, chambers, bye-washes, waste weirs, outfalls, discharge pipes, shafts, adits, tunnels, aqueducts, culverts, cuts, catch-waters, channels, conduits, mains, pipes, stand-pipes, junctions, valves, drains, telegraph, telephone, engines, apparatus, roadways, approaches, buildings, houses, works, and conveniences connected with the hereinbefore described works, or any of them, or incidental thereto, or necessary for conducting, controlling, inspecting, cleansing, repairing, or maintaining the same, and together with full power and right at all times of approach and access to the works aforesaid, or any of them.

To authorise the Corporation to deviate laterally from the lines of the intended works as shown upon the plans thereof, to be deposited as hereinafter mentioned, to such extent as may be indicated upon those plans, and to deviate vertically from the level shown on the sections hereinafter mentioned to such extent in either case as may be prescribed by the Bill.

To break up, alter, divert, or stop up, either temporarily or permanently, any roads, streets, highways, footpaths, bridges, streams, water-courses, sewers, drains, telegraphic and telephonic wires and tubes, which it may be necessary or convenient to break up, alter, divert, or stop up for the purposes of the intended works or of the Bill.

To empower the Corporation to purchase and take, or acquire by compulsion or agreement, or to take on lease, any lands, springs, streams, waters, houses, and hereditaments for the purpose of constructing the said intended works or for the purposes of the Bill, or of their Waterworks undertaking.
