Church Stretton Water.

(Incorporation of Company; Construction of Works; Limits of Supply of Water; Compulsory Purchase of Lands Water Rights, Easements, &c.; Provisions as to Supply and Fittings; Power to Levy Rates; Agreements with Local Authorities and Others; and other purposes).

NOTICE is hereby given that application is intended to be made to Parliament in the next Session for an Act for all or some of the following purposes (that is to say):—

To incorporate a Company (hereinafter referred to as "the Company") and to authorise the Company to construct waterworks and to supply water for all purposes within the parish of Church Stretton in the county of Salop.

To authorise the Company for the purposes of the proposed undertaking to make and maintain all or some of the works hereinafter described

wholly situate in the said parish of Church Stretton and county of Salop (that is to say):—

1. A reservoir to be formed by means of an embankment across the brook or stream which flows through New Pool Hollow into the Carding Mill Stream at a point 477 yards or thereabouts from and above the point where the first-mentioned stream flows into the said Carding Mill Stream such reservoir extending up and along the said stream for a distance of 264 yards or thereabouts from the said embankment. The said embankment will extend from the centre of the said stream 40 yards or thereabouts in a north-westerly direction and for a distance of 48 yards or thereabouts in a south-easterly direction.

2. An intake tank or reservoir to be situated on the southern bank of the Carding Mill Stream at a point 747 yards or thereabouts measured in a westerly direction from the point of confluence of the said streams.

3. An aqueduct conduit or line of pipes (No. 1) commencing at and out of the said intake tank and terminating in the said reservoir on the northern side thereof at a point 33 yards or thereabouts from the centre of the said proposed embankments.

4. An aqueduct conduit or line of pipes (No. 2) commencing at a point on the embankment of the said reservoir and terminating at a point in the hamlet of Little Stretton 50 yards or thereabouts measured in a southerly direction from the centre of the bridge carrying the road leading from Church Stretton to Craven Arms over the stream known as Ashes Hollow stream.

5. An aqueduct conduit or line of pipes (No. 3) commencing by a junction with the aqueduct conduit or line of pipes (No. 2) at a point on the road leading from Church Stretton to Shrewsbury at or near the junction of the said road with the Carding Mill Valley-road and terminating at a point on the said road leading from Church Stretton to Shrewsbury at the southern end of Mousehill Wood.

6. An aqueduct conduit or line of pipes (No. 4) commencing by a junction with aqueduct conduit or line of pipes (No. 2) at or near a point where the Station-road joins the said road leading from Church Stretton to Shrewsbury and terminating at a point where the said Station-road joins Watling-street.

To authorise the Company to deviate from the lines and levels of the intended works shown on the plans and sections to be deposited as hereinafter mentioned to such extent as may be shown upon the said plans and sections or be prescribed by the intended Act.

To enable the Company from time to time to make and maintain all such cuts channels aqueducts culverts tunnels drifts adits wells shafts pilot shafts bores drains sluices overflows wastewater channels weirs stand-pipes filter-beds water towers tanks banks walls tramways approaches engines machinery electric apparatus and appliances as may be necessary or convenient in connection with the intended works or any of them or for the obtaining raising taking and distributing of water.

To authorise the Company to collect impound take use divert and appropriate in and for the purposes of the intended works and of their undertaking the streams and waters aforesaid all of which flow into the River Severn and all streams springs and waters as will or may be intercepted or taken by the intended works or as may be found in or under any of the lands for the time being belonging to the Company or over or in respect of which they may acquire easements.
