conditions as may be prescribed by the Bill, of the Dutch River, and the beds, banks, and foreshores thereof, or some of them, or some part thereof, and of all or some of the estate, property, rights, powers, privileges, authorities, duties, and obligations of the Corporation in or in connection with the Dutch River, or any part thereof, and the beds, banks, and fore-shores thereof, and upon any such transfer to relieve, if thought fit, the Corporation from such duties and obligations, and to enable such parties to make other agreements and arrangements in relation to the Dutch River and the beds, banks, foreshores, and works thereof, or any part thereof, or the maintenance and use thereof, or in relation to all or some of the said estate, property, rights, powers, privileges, authorities, duties, and obligations of the Corporation, and to confirm any such agreement or arrangement which may have been or may hereafter be made.

To sanction and confirm a deed of grant and indemnity made the 8th day of November, 1873, between the Corporation and the then trustees of the Undertakers, whereby the Corporation granted and conveyed to the said trustees upon trust for the Undertakers their right, interest, and estate in the portion of the north bank and foreshore of the Dutch River in the township of Goole therein defined, and in the northern moiety of the river co-extensive therewith, and to enable or require the parties thereto to give effect to the grant and indemnity therein contained, and, if thought fit, to impose upon the Undertakers the obligations of the Corporation in reference to the repair, maintenance, and otherwise of such portion of bank, foreshore, and river, and to release the Corporation from such obligations.

To authorise the Undertakers and the Goole Urban District Council to enter into and carry into effect agreements and arrangements for the transfer to the Undertakers of the obligations, and rights of the district council in relation to the maintenance, repair, and working, and the taking of tolls for the opening of the bridge at Goole over the Dutch River, or some of such obligations and rights, or for the Undertakers taking over the maintenance or working of such opening bridge, or supplying steam, hydraulic, or other power for the working thereof, or for the redemption of or compounding for the tolls payable by vessels at such bridge, and other matters relating to such bridge, and the maintenance and working thereof, and to confirm any such agreement or arrangement which may have been already or may hereafter be made, or to make provisions in the Bill for effecting any of such objects.

To extend the time limited by the Ouse (Lower) Improvement Act, 1884, for the completion of the works by that Act authorised and works connected therewith.

To amend the provisions of Section 64 of the last-mentioned Act as to the reserve fund thereby required to be formed, and to reduce or alter the amount of such reserve fund.

To extend the time limited by the Act of 1891 for the completion of the new canal and widening of the Knottingley and Goole Canal by that Act authorised and works connected therewith.

To revive the powers granted to the Undertakers by the Act of 1895 for the compulsory purchase and taking of lands for the purposes of the alteration of the bridges and approaches thereto known as Harrison's Bridge, Birkwood Bridge, King's-road Bridge, and Jackson's Bridge, and the canal widenings and works connected therewith by that Act authorised, and to extend the time limited by that Act for such purpose, and to extend the time limited by the same Act for the completion of the works anthorised by that Act (except as regards Gagg's Bridge) and works connected therewith.

To authorise the Undertakers to sell and supply water from their Barnsley Canal or reservoirs connected therewith to any company or person requiring a supply, and to amend the Act 33 Geo. III, cap. 110, and the Barnsley Canal Transfer Act, 1871, in relation thereto.

To make provisions for preventing trespass on, or obstruction to, the towing paths and land used as towing paths along the canals or navigations belonging to or under the jurisdiction of the Undertakers, or the use thereof for other than navigation purposes, and the acquisition of rights therein, and to impese penalties in respect thereto.

To empower the Undertakers to enter upon lands adjoining or near any of their canals or navigations in the said West Riding, and to take materials from such lands for any works necessary to prevent or remedy damage to such eanal or navigation or works thereof from floods or accidents, and also to confer powers on the Undertakers of entering apon, occupying, and using any such lands for the purpose of the deposit of dredgings, materials; and spoil taken out of any canal or navigation.

To repeal, aller, or modify Sub-section 2 and other provisions of Section 11 of the Act of 1891 for the protection of the Dan Drainage Commissioners in connection with the canal authorised by that Act, and to make new provisions as to the aqueduct for carrying the said canal over the River Don, the prevention of flooding in consequence thereof, and for the protection of the said Commissioners and the banks, drains, and works belonging to or under their jurisdiction in connection with the construction and maintenance of such canal, and such other provisions as may be necessary or expedient in reference to the crossing of the River Don by such canal.

To empower the Undertakers and the Went Drainage Trustees and the Dun Drainage Commissioners respectively to make and enter into agreements and arrangements as to the construction of the aqueducts for carrying the canal authorised by the Act of 1891 as altered by the Bill over the River Went and the River Don, and to confirm any such agreements or arrangements which have already been or may be made.

To empower the Undertakers for the purposes of the Bill or for giving effect to the provisions thereof or of any such agreements, or otherwise to dredge, scour, maintain, alter, and improve the bed or channel of the said lastmentioned rivers, or either of them, at or near the said aqueducts or for such distance therefrom as may be prescribed, so as to provide for the free passage and flow of water thereto and therefrom and under such aqueducts, and to remove shoals, banks, and obstructions therein, and to do all other acts necessary or expedient for such purposes.

To authorise the Undertakers to apply for the purposes of the Bill any funds or moneys belonging to them, or to raise by mortgage, or the creation and issue of debenture stock or otherwise, and apply for such purposes any money which under any Act relating to their
