forming, and distributing electrical energy, and to generate, transform, and distribute such energy.

To empower the Noting Hill Company to acquire by compulsion or agreement, and to hold and use for the purpose of enlarging or extending their existing station at Bulmerplace, Notting Hill, for generating electrical energy the lands and buildings hereinafter described, or some part or parts thereof (that is to say :--

- Certain lands and buildings situate in the parish of Saint Mary Abbotts, Kensington, known as Nos. 1, 2, 3, 4, 5, 6, and 7, in Bulmer-place, Notting Hill, and lying on the east side of and adjoining the existing electrical station of the Notting Hill Compary, and bounded as follows (that is to say):—On the north side thereof by Bulmer-place, on the east side thereof by the house and premises known as IA, Bulmer-place, on the south side thereof by the houses and premises known as Nos. 126, 128, 130, 132, 134, and 136, High-street, and on the west side thereof by the said existing electrical station of the Notting Hill Company.
- Also certain other lands and buildings situate in the same parish, and known as Nos. 128, 130, 132, 134, 136, 138, and 140, Highstreet, Notting Hill, and bounded as follows (that is to say) :--On the west side thereof by the houses, stabling, and premises known as Nos. 142, 144, and 146, High-street, on the south side thereof by the High-street, on the east side thereof by the stabling and premises known as No. 126, High-street, and on the north side thereof by the said existing electrical station of the Notting Hill Company, and by the houses and premises known as Nos. 2, 3, 4, 5, 6, and 7, Bulmer-place.
- Also certain other lands and buildings situate in the same parish, and known as Nos. 12, 13, 14, 15, 16, 17, and 18 in Victoria-gardens, and lying on the western side of and adjoining the said existing electrical station of the Notting Hill Company, and bounded as follows (that is to say) :--On the west side thereof by Victoriagardens, on the east and north sides thereof by the premises of the said existing electrical station, and on the south side thereof by the houses, stabling, and premises known as Nos. 144, 146, and 150, Higb-street.
- Also certain lands and buildings in the same parish, known as Nos. 131 and 133 in Lancaster-road, and No. 41 in Saint Mark's-road, Notting Hill, bounded as follows (that is to say):—On the north side thereof by the Lancaster-road, on the west side thereof by the house and premises known as No. 135, Lancaster-road, on the east side thereof by the Saint Mark's-road, and on the south side thereof by the house and premises known as No. 39, Saint Mark's-road, and the stabling and premises known as No, 5, Saint Mark's-mews and Nos. 7 and 8, Talbot-mews.

And to empower the Notting Hill Company, upon all or any of such lands and premises, and upon lands and premises already belonging to the Notting Hill Company, to erect, maintain, work, and use all necessary and convenient plant, machinery, buildings, works, and conveniences for generating, transforming, and

distributing electrical energy, and to generate, transform, and distribute such energy.

To empower the two Companies, or either of them, on the one hand, and the West London Railway Company, the Great Western Railway Company, the London and North Western Railway Company, and the Central London Railway Company, and the House to House Electric Light Supply Company, Limited, and the vestries of the parishes of Saint Mary Abbotts, Kensington, and Hammersmith, or any or either of them, on the other hand, to enter into and carry into effect agreements with respect to all or any of the matters aforesaid, and with respect to lighting the streets of the said parishes, and with respect to the supply of electrical energy, and any other matters connected with, or arising out of, or which may facilitate the carrying out of the objects and purposes of the intended Act, and to confirm or give effect to any such agreement which may have been or may be entered into prior to the passing of the intended Act.

To vary or extinguish all existing rights and privileges which would or might in any way prevent or interfere with the objects of the intended Act, and to confer other rights and privileges.

To alter, amend, extend, or repeal all or some of the provisions of the Kensington and Knightsbridge Electric Lighting Order, 1889, and the Kensington, Knightsbridge, and Chelsea Electric Lighting Act, 1893, and any other Acts or Orders relating to the Kensington Company, and also the Memorandum of Association of the Kensington Company; and of the Notting Hill Electric Lighting Orders, 1889 and 1895, and any other Acts or Orders relating to the Notting Hill Company, and also the Manuardum of Accession of the Notting Memorandum of Association of the Notting Hill Company; and the Acts 6 and 7 Will. IV c. 79, and 3 and 4 Vict., c. 105, and any other Act or Acts relating to the West London Railway Company; the Act 5 and 6 Will. 1V, c. 107, and any other Act or Acts relating to the Great Western Railway Company; the Act 9 and 10 Vic., c. 204, and any other Act or Acts relating to the London and North Western Railway Company; the Central London Railway Act, 1891, and any other Act or Acts relating to the Central London Railway Company.

And notice is hereby given that on or before the 30th day of November next, plans and sections of the intended works and plans of the lands to be acquired, with a book of reference to those plans, together with a copy of this Notice as published in the London Gazette, will be deposited with the Clerk of the Peace for the county of London, at his office at the Sessions House, Clerkenwell; and with the Vestry Clerk of the parish of Hanmersmith, at his office at the Vestry Hall, Hammersmith; and with the Vestry Clerk of the parish of Saint Mary Abboits, Kensington, at his office at the Town Hall, Kensington.
