

some of the provisions of the Acts herein-after mentioned relating to or affecting the Company and of the Bill, and to authorise the Company to make, demand, collect, levy, and recover rates, rents, and charges for the supply of water within such extended limits of supply, and for and in respect of all other powers, rights, and privileges which may be conferred upon the Company by the Bill, and to confer, vary, or extinguish exemptions from the payment of such rates, rents, and charges, and to define and prescribe the limits within which the Company are by the before-mentioned Acts now authorised to supply water, and where any change has occurred in the name, description, or boundary of any of the parishes or places within such limits, to explain and adopt such changed name, description, or boundary.

9. To authorise the Company to lay down, maintain, take up, alter, renew, and repair mains, pipes, and other works in, through, under, over, across, and along, and to cross, break up, alter, divert, stop up, or otherwise interfere with, either temporarily or permanently, any main or other roads, highways, footways, occupation roads, footpaths, streets, public places, bridges, canals, navigations, towing paths, railways, tramways; sidings, works, pipes, telegraph, telephone, electric, and other works and wires, sewers, drains, rivers, streams, brooks, and watercourses in the parishes and places before mentioned, or any of them, so far as may be necessary or convenient for all or any of the purposes of the Bill.

10. To empower the Company from time to time to discharge water from any of the intended or existing works of the Company into any river, stream, or watercourse, whether within or beyond the Company's limits of supply.

11. To empower the Company to require the owner of any dwelling-house or other property, or any other person requiring to be supplied with water by the Company, to provide a cistern or cisterns for the storage of water in any dwelling-house or other property so to be supplied, and to authorise the Company to prescribe the size, nature, and description, and the mode and place of fixing such cistern or cisterns in or upon such dwelling-house or other property as above-mentioned, and to make regulations with reference to the matters aforesaid or any of them, and to provide for the imposition and recovery of penalties for any breach of such regulations, and also to provide that the Company shall not be bound to supply water to any such dwelling-house or other property as aforesaid if any such owner or other person as aforesaid fails to provide and maintain such cistern or cisterns.

12. To authorise and empower the Bishop's Waltham Waterworks Company, Limited (hereinafter called "the Bishop's Waltham Company"), to sell and the Company to purchase, either by compulsion or agreement, or otherwise to provide for the transfer to and vesting in the Company the whole or any part of the undertaking of the Bishop's Waltham Company and all or any of the powers, rights, privileges, duties, and obligations conferred or imposed upon them by the Bishop's Waltham Water Order, 1894, scheduled to and confirmed by the Water Orders Confirmation Act, 1894, or otherwise, together with the full benefit of all pending contracts, agreements, and engagements to which the Bishop's Waltham Company are or may be entitled in connection with their said undertaking, and together with all lands,

works, mains, pipes, plant, engines, machinery, and all other appliances, apparatus, goods, chattels, effects, and property of every description used or provided or intended to be used and provided for the purposes of or in connection with the undertaking of the Bishop's Waltham Company, upon and subject to such terms and conditions, pecuniary or otherwise, as have been or may be agreed upon between the Bishop's Waltham Company and the Company or as may be prescribed by the Bill, and to authorise the Company in their own name to have and to hold, maintain, and improve the said undertaking, and to sanction, confirm, and give effect to any agreement or agreements which have been or may be entered into with reference to the matters aforesaid or any of them.

13. To provide, if necessary, for the settlement by arbitration of the amount of compensation for, and the terms and conditions of the transfer of the undertaking of the Bishop's Waltham Company to the Company, and of all matters and things connected therewith.

14. To provide for the payment, distribution, and application of the purchase money or other consideration upon or in respect of any such sale or transfer as aforesaid, and, if necessary, for the dissolution of the Bishop's Waltham Company and the winding-up of their affairs, and otherwise to make all such provision as may be necessary for or ancillary to such sale and transfer.

15. To provide that in the event of the West Hampshire Water Company (hereinafter called "the West Hampshire Company") failing to supply water in the before-mentioned parish of Brockenhurst in accordance with the provisions of the West Hampshire Water Act, 1893, and within the period limited by that Act, or within such earlier or other period as may be prescribed by the Bill, the powers of the West Hampshire Company to supply water in that parish shall cease and determine, and that the said parish of Brockenhurst shall thereupon be excluded from the limits of supply of the West Hampshire Company and be included within the limits of supply of the Company as proposed to be extended as hereinbefore mentioned, and also to provide for the amendment or repeal of the provisions of the West Hampshire Water Act, 1893, with reference thereto, and the Bill will or may authorise and empower the West Hampshire Company and the Company to enter into and carry into effect any agreement or agreements which have been or may be entered into with reference to the matters aforesaid, or any of them, and sanction, confirm, and give effect to any such agreement or agreements.

16. To extend the period limited by Section 4 of the South Hants Water Act, 1894, for the supply of water by the Company to the parishes of Mottisfont, Farley Chamberlayne, Hursley, Compton, Twyford, Durley, Bishop's Waltham, Titchfield, Dibden, Fawley, Exbury, and Lyndhurst, or some or one of them, as in that section mentioned, and to provide that the restriction on the construction of waterworks by a local authority imposed by Section 52 of the Public Health Act, 1875, shall not in respect of the Company, and so far as regards the aforesaid parishes or any or either of them or any part or parts thereof respectively which the Company have not been or are not in a position to supply, apply to or be binding on the local authority, as defined by the last mentioned Act, of such parishes or any or either of them for
