1. To authorise the Company to make and maintain in the parish of St. Marylebone, in the county of London, the following works, or some or one of them, or some part or parts thereof

(A) A tunnel or waterway, commencing by a junction with the Regent's Canal on its northern side, at a point 20 yards or thereabouts eastward of the easternmost side of the bridge carrying Grove-road over the said eanal, and terminating at a point 26 yards or thereabouts north-eastward of the junction of North Bank with Grove Road.
