situate on the north-eastern side of Euston Square and the north-western side of Euston Road where it joins the said Square on the north-eastern side comprising the premises numbered 69 and 69a Euston Square and 174 Euston Road;

(8) Land in the Parish of Saint Matthew Bethnal Green situate to the northward of and adjoining the Bethnal Green Fire Brigade Station of the Council comprising the premises numbered 4 Chester Place

For purposes of or connected with a Gas

Meter Station-

(9) Land in the Parish of Saint John-the-Evangelist Westminster forming the site of the present Gas Mcter Testing Station of the Council bounded on the north by Storey's Chambers, on the east by the rear of houses and land abutting on Great Smith Street, on the south by property in the occupation of Mr. Collins, and on the west by St. Ann's Street;

For purposes of Open Spaces—
(10) Land in the Parish of Saint Anne Limehouse known as the Brickfield Limehouse bounded on the south and east by the rear of houses in Dixon Street and Locksley Street, on the north by the southern end of Dora Street, and on the west partly by the end of Endive Street and partly by the Standard Saw Mills property.

Spitalfields Market.

To enable the Council to purchase and acquire by Agreement the freehold interest in the lands forming the site of Spitalfields Market and lands adjoining thereto in the Parish of Christchurch Spitalfields and County of London the said lands being bounded on the east by Commercial Street on the north by Lamb Street on the west by Crispin Street and on the south by Brushfield Street

Land at Tooting Bec Common.

To authorise the Council on the one hand and the Master Fellows and Scholars of Emmanuel College in the University of Cambridge on the other hand to enter into and carry into effect an Agreement or Agreements with reference to an exchange of certain lands in the Parish of Streatham in the County of London forming part of and adjoining Tooting Bec Common for other land near thereto the property of the said Master Fellows and Scholars forming part of Hyde Farm in the Parishes of Streatham and

Clapham in the said County.

To provide for vesting in the said Master Fellows and Scholars the piece of land to be given up to and acquired by them freed and discharged from all rights of common rights of way and other public and private rights in over or affecting the same and to annex the lands to be acquired by the Council or part or parts thereof to Tooting Common and to provide for the extinction or transfer to the Council of all rights of way or common and all other rights of the said Master Fellows and Scholars and of their tenants in over or upon the said lands or to confirm any agreement or agreements which have been made or may be made between the Council and the said Master Fellows and Scholars touching the matters aforesaid

To provide that the lands so acquired by the Council shall form part of Tooting Common for purposes of by-laws and all other purposes.

Golder's Hill Estate Hampstead.

To authorise and provide for contributions by

Parish of Paddington and the Vestry of the Parish of Saint Marylebone towards the purchase by the Council of certain lands adjoining or near to Hampstead Heath and known as Golder's Hill and to provide for the maintenance management and control of such lands as and for the purposes of a park open space or recreation ground in connection with or as part of Hampstead Heath and to fix the hours during which the same shall be open to the public.

To enable the Council from time to time to let or provide for the use of the house or buildings on the said Golder's Hill estate together with any lands immediately adjoining the same for such purposes as may be defined in the intended Act and in such manner and subject to such conditions as may be agreed to by the Vestry of the Parish of Saint John Hampstead and subject to such other consents as the Bill

may prescribe. Extensions of Time for Certain Works.

To further extend the periods limited for the compulsory purchase of lands for and the construction of the Works described as the Widening of Saint George's Place Knightsbridge in the parishes of Saint George Hanover Square and Saint Margaret Westminster authorised by "The London Council (General Powers) Act 1891."

To extend the time limited for the completion of the Works described as the Highgate Archway Improvement in the Parishes of Saint Mary Islington in the County of London and Saint Mary Hornsey in the County of Middle-sex authorised by "The London County Council

(Improvements) Act 1894.

To extend the time limited by "The London County Council (General Powers) Act 1896" for the purchase under that Act of the lands known as the "White House" Beerhouse and property connected therewith situate at property connected therewith situate at Hackney Marshes in the Parish of Hackney and County of London.

Amendment of Acts.

To apply all or some of the provisions of "The London County Council (Subways) Act 1893" to the following Works viz.:—

(I) The Widening of the Strand described in and authorised by "The London County Council (Improvements) Act 1897";
(2) The New Street in Southwark, the Long

Lane Widening, and the Widening of Old Street and Goswell Road, described in and authorised by "The London County Council (General Powers) Act 1897 "

and to make such provisions applicable during as well as after the construction of the Works.

To alter and amend certain of the provisions of "The London County Council (Vauxhall Bridge) Act 1895" with reference to the construction of the new Bridge at Vauxhall and the Works connected therewith.

To enable the Council to grant leases of lands which had been acquired for Fire Brigade purposes but which have ceased to be used for such purposes and to amend so far as may be necessary for that purpose "The Metropolitan Fire Brigade Act 1865" and any Act or Acts relating to lands acquired by the Council for fire

brigade purposes.
To amend the provisions of "The London County Council (Tower Bridge Southern Approach) Act 1895" and of "The London" County Council (Improvements) Act 1897" relating to the Improvement Areas and Charge the Middlesex County Council the Vestry of the Parish of Saint John Hampstead the Vestry of the Parish of St. Pancras the Vestry of the apportionment of the Improvement Charge
