The Lancashire Electric Power Company.

(Incorporation of Company; Power to Construct Works and to Produce and Supply Electrical Energy within part of the counties of Lancaster and Chester; Agreements with Local Authorities and others; Power to take Lands and Easements Compulsorily and by Agreement; Incorporation and Amendment of Acts.)

NOTICE is hereby given, that application is intended to be made to Parliament in the ensuing Session for leave to bring in a Bill for the following or some of the following purposes (that is to say):—

1. To incorporate a Company (hereinafter called "the Company") and to authorise and empower the Company to produce, store, supply, and sell electrical energy (in this Notice called "electricity") for public and private lighting, motive power, heating, chemical reduction, trade, manufacturing, and all public and private purposes as defined in the Electric Lighting Act 1882, within the area of supply hereinafter mentioned, comprising amongst others the city of Liverpool, the city of Manchester, and the towns of Preston, Burnley, Bolton, Bury, Blackburn, Oldham, Ashton, Stalybridge, Rochdale, Wigan, Warrington, Widnes, St. Helens, Runcorn, Southport, Chorley, Stockport, Macclesfield, Birkenhead, Salford, Accrington, and Darwen, in the counties of Lancaster and Chester. The area within which the Company intend to supply electricity comprises so much of the counties of Lancaster and Chester as is contained within the area more particularly delineated on the map deposited as hereinafter mentioned, and includes the before-mentioned cities and towns and all cities, county and other boroughs, towns, villages, urban districts, rural districts, parishes and extra-parochial and other places within the

parts of the counties before-mentioned (hereinafter called "the area of supply").

2. To authorise the Company to acquire, construct, maintain, and use, and from time to time to sell, let, and otherwise dispose of machinery, plant, and apparatus for the production, storage, regulation, measurement, installation, distribution and supply of electricity, and for the recovery of any bye products obtained from fuel consumed in the production of electricity, and from time to time to improve, enlarge, extend, discontinue, or displace or sell and dispose of all such machinery, appliances, and other property as shall not be required for the purpose of manufacturing and working the machinery, plant, and apparatus to be used for the production, storage, regulation, measurement, installation, distribution, and supply of electricity. The works intended to be constructed, used, and maintained are as follows:—

Four central or principal stations at which electricity will be generated or collected, and a system of distributing stations, transformers, cables, mains and tubes by which electricity will be conveyed and distributed from such stations to any place or places where it is required within the area of supply.

3. To authorise the Company to lay down, place, maintain, and use, and to take up, sell, and otherwise dispose of electric and other mains, storage, and other batteries, accumulators, cables, conductors, services, wires, tubes, pipes, insulators, meters, reservoirs, distributing, cut out and other boxes, switches, transformers, lamps, fittings, motors, and other apparatus for transmitting, storing, measuring, regulating, and distributing electricity for lighting, motive power, and other purposes, public and private, or for converting the same into power, heat, or otherwise, and any pipes, conduits, or other channels of water supply for feeding or condensing purposes, or to be otherwise used for the purposes of or in connection with the works and lines to be erected, used, and maintained (in this Notice, called "electric lines,") in, through, under, over, along, and across, and either above or beneath the surface of, and for that purpose to cross, open, break up, divert, alter, or otherwise interfere with temporarily all roads, streets, footpaths, and other public places, and all railways, tramways, canals, rivers, watercourses, bridges, sewers, drains, gas, water, and other pipes, telegraphic, telephonic and electric posts, wires, pipes, pneumatic and other tubes, and apparatus and works of every description within the area of supply.

4. To authorise the Company on the one hand, and any corporation, county and district council, or other local or road authority, and any railway, tramway, dock, canal or other company on the other hand, to enter into and carry into effect, and alter, rescind and renew contracts for empowering the Company to enter upon and break up any streets, roads and other places before mentioned, and for the supply to any such corporations, councils, bodies, companies and persons of electricity, and if thought expedient to authorise such corporations, councils and other bodies, authorities and companies to exercise the powers with respect to the breaking up of streets and other places before referred to for those purposes.

5. To empower the Company, with the consent of the road authorities and subject to their approval, to lay pipes and works within and beyond the area of supply for the time being, and to confer upon the road authorities all necessary powers, rights and privileges with reference thereto.
