the Corporation in regard to borrowing under the Public Health Act, 1875, and the Hastings Improvement Act, 1885, and to empower the Corporation to raise any of the said moneys by the creation of Hastings Corporation Redeemable Stock.

24. To vary or extinguish all or any rights and privileges inconsistent with, or which would or might in any way interfere with the objects of the Bill, and to confer other rights or privileges.

25. And it is intended, so far as may be necessary for any of the purposes of the Bill, to amend or repeal the provisions, or some of the provisions, of the local and personal Acts followprovisions, or the local and personal Acts follow-ing, or some of them, that is to say: 29 Geo. III, cap. 27; 1 Geo. IV, cap. 12; 2 and 3 William IV, cap. 91; 17 and 18 Vic., cap. 6; The Hastings Improvement Act, 1885; and any other Act or Acts relating to the corporation or borough, and of certain Provisional Orders made and confirmed in the years 1851, 1860, 1866, 1875, and 1877, relating to the stings and 1866, 1875, and 1877, relating to Hastings and St. Leonards.

26. The Bill will incorporate with itself, with or without variation, such provisions as may be thought expedient of The Towns Police Clauses Act 1847; The Towns Improvement Clauses Act 1847; The Public Health Act 1875; The Local Loans Act 1875; The Lands Clauses Acts; The Tramways Act 1870; and the Municipal Corporations Act 1882.

27. Duplicate plans and sections, showing the lines, situations and levels of the said tramways and other works, the plans, also showing the additional lands which may be taken under the powers of the intended Act, and a Book of Reference to such plans and a copy of the Notice, as published in the London Gazette, will be de-posited for public inspection on or before the 30th day of November instant, with the Clerk of the Peace for the Eastern Division of the County of Sussex at his office at Lewes, and on or before the same date a copy of the said plans, sections, Book of Reference and Notice will be deposited at the office of the Town Clerk at the Town Hall, Hastings

Printed copies of the Bill will be deposited at the Private Bill Office of the House of Commons on or before the 21st day of December next.
