Work No. 5.-A new road (in substitution) for road to be partly submerged) to be situate in the said Parishes of Llanafan-fechan Llanlleonfel and Treflis commencing in the Parish of Llanafan-fechan by a junction with the new road (Work No. 3) at a point 4 chains or there-abouts measured from Ty-Segur farm-house along the footpath leading towards Bryn-y-bwch and terminating in the Parish of Llanlleonfol by a junction with the new road (Work No. 3) at a point in the fence separating the enclosures numbered 1084 and 1078 on the Ordnance Map <sup>1</sup>/<sub>3,600</sub> Brecknock Sheet X. 12, 11 chains or thereabouts south-west of the farm-house of Maes-llech.

Work No. 6.—A Railway situate in the said Parishes of Llanganten Llanafan-fechan Llanlleonfel and Trefis (being a deviation of the existing Central Wales Section of the London and North Western Railway) commencing by a junction with that Railway in the Parish of Llanganten at a point 26 chains or thereabouts measured in a westerly direction along that Railway from the western end of the tunnel near Cilmery Station and terminating in the Parish of Treflis by a junction with the said existing Bailway at a point 1 mile 67 chains or thereabouts measured along that Railway westward from the Llangammarch Station and about 24 chains eastward of the point where the said Railway crosses on the level a road to Cilddu. Work No. 7.—Towy Reservoir.

An impounding or storage reservoir (hereinafter called "the Towy Reservoir") situate partly in the Parish of Llanddewi Abergwesyn (Rural District of Builth) and partly in the said parish of Llanwrtyd in the County of Brecknock partly in the parish of Doethie-Camddwr (Rural District of Tregaron) and partly in the Parish of Caron-Uwch-Clawdd, in the County of Cardigan to be formed by means of a dam or embankment across the River Towy at a point 4 chains or thereabouts southward of the confluence of the Camddwr and Nant-Gwrach streams with the River Towy. The said dam or embankment will commence in the Parish of Llanwrtyd at a point about 2 chains south-eastward of the centre of the River Towy where the said dam or embankment will cross that river and terminate in the Parish of Doethie-Camddwr at a point 5 chains or thereabouts north-westward of the centre of the said river where it will be crossed by the said dam or embankment.

The said Reservoir will extend from the lastly hereinbefore described dam or embankment up the River Towy to a point 59 chains or there-abouts north from the point where the said intended dam or embankment will cross the said river.

Work No. 8.—An aqueduct or conduit (wholly or for the most part in tunnel) situate in the said Parishes of Llanwrtyd and Llanddewi Abergwesyn and in the said Parish of Caron-Uwch Clawdd commencing in the Towy Reservoir (Work No. 7) on or near the boundary between the said Parishes of Llanddewi Abergwesyn and Caron-Uwch-Clawdd at or near the confluence of the Camddwr and Nant-Gwrach streams with that river and terminating in the Parish of Llanwrtyd at a point on the River Yrfon 8 chains or thereabouts south-east of the junction of the Nant-Lledgwial stream with that river.

Work No. 9.- A new road or road diversion situate in the said Parishes of Llanwrtyd and Llanddewi - Abergwesyn : commencing in the

existing road leading from Trawsnant to Fanog at a point 8 chains or thereabouts south-west of the crossing by that road of the Nant-Gwrach stream and terminating in the Parish of Llanddewi-Abergwesyn by a junction with the said existing road at a point 29 chains or thereabouts measured along that road from the said crossing of the Nant-Gwrach stream.

Work No. 10.-A new road or road diversion situate in the said Parish of Llanddewi-Abergwesyn commencing by a junction with the road leading from Trawsnant to Fanog at a point 4 chains or thereabouts south of the crossing by that road of the Nant Craflwyn stream and terminating by a junction with the said existing road at a point 3 chains or there-abouts north of the said crossing of the Nant Craflwyn stream. Work No. 11.—Doethie Reservoir.

A compensation Reservoir (hereinafter called "the Doethie Reservoir") situate partly in the Parishes of Doethie-Pysgotwr, (Rural District of Tregaron) and Doethie Camddwr, in the County of Cardigan and partly in the Parish of Cilycwm in the County of Carmarthen to be formed by means of a dam or embankment across the River Doethie. The said dam or embankment will commence in the Parish of Cilycwm at a point of 3 chains or thereabouts measured. in a south-westerly direction from the road leading from Llandovery to Rhyd-y-Groes and 8 chains or thereabouts measured in a southerly direction from the said Rhyd-y-Groes farmhouse the said point being in the field numbered 2707 on the Ordnance Map 1 500 Carmarthenshire III. 13 and terminate in the Parish of Doethie-Camddwr in a field or enclosure numbered 5 on the Ordnance Map 1 Cardigan-shire XXXVI. 13 at a point 8 chains or there= abouts measured in an easterly direction from the before-mentioned Rhyd-y-Groes farm-house.

The Reservoir will extend from the said dam or embankment up the said River Doethie to ä point on that river 1 mile and 10 chains or thereabouts north of the junction of the River Pysgotwr-Fawr therewith and up the River Pysgotwr-Fawr to a point on that river 68 chains or thereabouts north-westward of the said junction.

Work No. 12.-A new road or road diversion situate in the said Parish of Cilycwm and the said Parish of Doethie Camddwr commencing in the Parish of Cilycwm by a junction with the existing road from Llandovery to Henfaes at a point II chains or thereabouts measured in a north-easterly direction from the house called Maes-y-Meddygon on the Ordnance Map  $\frac{1}{2600}$ Carmarthen X. 1 and terminating in the Parish of Doethie Camddwr by a junction with the last-mentioned existing road at a point 11 chains or thereabouts measured in a north-easterly direction from the Troed-y-rhiw-rhuddwen farm-house shown on the Ordnance Map 1 100 Cardiganshire XXXVI. 13.

Work No. 13.- Upper Wye Reservoir.

An impounding or storage reservoir (herein-after called "the Upper Wye Reservoir") situate in the Parishes of Llansantffraid-Cwmdeuddwr and Saint Harmon in the County of Radnor and in the Parish of Llangurig in the County of Montgomery to be formed by means of a dam or embankment across the River Wye at a point 13 chains or thereabouts measured in a westerly direction from a house called Glyn-Gwy on the Ordnance Map 1 Radnorshire Sheet VII. 16. The said dam or embankment will commence in the Parish of Llansantffraid-Parish of Llanwrtyd by a junction with the Cwmdeuddwr in a plantation or enclosure
