underground or overhead, or by means of electric (motors or accumulators carried in or attached to carriages; in the case of steam such power is intended to be carried with the carriages or applied by means of locomotives or of cables, wires, or ropes placed under the surface of the streets and in connection with a stationary engine or stationary engines, and in the case of pneumatic, gas, and oil, or other mechanical or natural power, the power is intended to be carried with or applied to carriages, or applied by means of locomotives or by means of cables.

To empower the Corporation to attach to any house or building such posts, brackets, and conductors, wires, tubes, mains, plates, cables, ropes. .and apparatus, and to place and maintain the same in any streets or highways within the borough, and to make and maintain such openings and ways in or under surface of any roads or streets as may be necessary or convenient whether for the actual working of the tramways or for providing access to or in connection with any engines, machinery, or apparatus,

To authorise the Corporation to provide and run omnibuses or motor-cars, either temporarily or permanently, from and to any part of the borough, to such place or places within or without the borough as they may consider advisable, and whether in connection with or independent of the Tramway Undertaking, and to empower them to levy and take such tolls, rates, or charges for the use of such omnibuses or motor-cars, or any of them, as they may think reasonable, or as may be specified in the Bill.

To enable the Corporation to make and enforce bye-laws with respect to the working, use, management, regulation, and the fixing of the charges for the use of their carriages and tramways, and generally to make and enforce such bye-laws and regulations with reference to all or any of the matters mentioned or referred to in this Notice, and to attach penalties to the breach or non-observance of such bye-laws and regulations, or of any provisions of the Bill as may be contained in and prescribed by the Bill.

To empower the Corporation to acquire, hold, and use patent and other rights and licences.

To authorise the Corporation to appropriate any of their lands for the purposes of the Bill, and to acquire additional lands by agreement.

To provide that the cost of acquiring, laying out, improving, and maintaining the Markeaton Recreation Ground, situate within the borough of Derby, and recently acquired or agreed to be acquired by the Corporation for the use, benefit, and enjoyment of the inhabitants of the borough shall be borne by the borough, and not by any particular district or districts thereof, and that such cost shall be borne by or defrayed out of the district fund and general district rate, and out of the borough fund or borough rate, or any or either of them, in such amounts and proportions as may be provided by the Bill, or out of moneys raised or borrowed, or to be raised or borrowed, on the security of the revenues of the Corporation, and of the district fund and general district rates and borough fund and borough rate of the borough or any or either of those funds or rates, or by the creation and issue of Derby Corporation Stock, or by such other means as the Bill may prescribe or provide for, and also to provide that all costs and expenditure incurred, or to be incurred, in respect of the said Markeaton Recreation Ground, or incidental thereto, shall be deemed, and be costs and expenditure of the revenues, rates, and property of the

so far as may be necessary for all or any of those purposes respectively, to repeal, alter, or amend all or some of the provisions of the Derby Corporation Act, 1877, the Derby Corporation Act, 1882, the Derby Corporation Act, 1890, and particularly the provisions contained in Sections 43 to 46 (both inclusive) of the Derby Corporation Act, 1877.

To make better provision for the prevention or spread of infectious diseases, whether within or without the Borough, and especially in regard to the following matters :-

The selling or offering for sale of milk from cows affected with tuberculosis, the selling or offering for sale of meat so affected, and to constitute it an offence for which penalties will be imposed by the Bill for any person to have in his possession for the purpose of consumption, whether of persons or animals, any milk or meat so affected, and requiring notice to be given of all animals affected with the said disease, and to empower the Corporation to give effect in any way that may appear to them expedient, or as may be prescribed by the Bill or by Parliament to the Report of the Royal Commission on Tuberculosis.

To transfer, to vest in, and impose upon the Corporation every right, custom, privilege, power, duty, liability, obligation, and immunity now vested in or imposed upon the Board of Guardians of the Derby Union with respect to the assessment of property.

To confer upon the Corporation the power of Vestry under the Poor Rate Assessment and Collection Act, 1869.

To confer upon the Corporation the power to appoint and to revoke the appointment of poor rate collectors.

'To confer upon the Corporation the powers, duties, and liabilities of overseers.

To empower the Corporation to borrow or raise money for any of the purposes of the intended Act, and to charge the same upon the revenues of the Corporation borough fund and borough rate, and general district fund and rate, or on any of such securities, and to execute and grant mortgages and to authorise the Corporation to apply any of their existing funds or any moneys they are authorised to borrow for any of the purposes of the intended Act.

To enable the Corporation to issue redeemable stock bearing a less rate of interest than three

per centum per annum. To provide that the restrictions contained in Section 234 of the Public Health Act, 1875, as to the borrowing of money shall not apply to any moneys which the Corporation may be empowered to borrow under any statutory borrowing power, the words "statutory borrowing power" being defined as in S. 68 (1) of the Derby Corporation Act, 1882.

To prescribe the form of mortgages and bonds issued or to be issued by the Corporation, for securing the repayment of any moneys borrowed by them, for any purposes for which they are for the time being authorised to borrow money, and for charging such moneys upon all or any of the revenues, rates, and property of the Corporation, and for making the same a first charge thereon, and to make other provisions in regard to securities given by the Corporation.

To empower the Corporation to issue securities, bonds, or other obligations, to secure the repayment of any moneys borrowed by the Corporation, and to provide that such securities, bonds, and obligations shall be a charge upon all or any applicable to the whole borough of Derby, and Corporation, and that such securities, bonds, and
