Leeds Corporation

(Extension and Improvement of Kirkgate Market; Erection of Hall for Various Purposes; New Street Works; Tramway in Townships of Armley and Bramley, and parishes of Padsey, Farsley, and Calverley; Gange and Motive Power; Working of Tramway by Corporation; Purchase or Lease of Light Railway; Breaking-up and Interference with Streets; Subsidiary Works; Compulsory Parchase of Land and Easements; As to Superfiuous Land and Taking of Part only of Buildings; Land for Building Parposes; Water-closets for New Houses; Swimming, Turkish, and other Baths; Burial Grounds; Tuberculusis ; Entry into Dairies, Byres, and Cowsheds Within and Beyond City; Prohibiting Persons from Driving more than One Vehicle; Tolls, Rates, and Charges; Borrowing of Money for Various Purposes; Issue of Promissory Notes; Application of Sinking Fund; Confirmation or Alteratiou of Corporate Style; Incorporation and Amendment of Acts.)

NOTICE is hereby given, that application is intended to be made to Parlinment in the next Session by the Lord Mayor, Aldermen, and citizens of the city of Leeds (hereinafter called the Corporation and city respectively) for tur Act for all or some of the following objects or purposes (that is to say):Kirkgate Market.

1. To anthorise the Corporation to extend and improve Kirkgate Market, and to appropriate the lands following or some of them for market purposes (that is to say) :--

All that piece of land bounded on the southern side by Kirkgate Market, on the western side by Harewood-street, on the northern side by Nelson-street, and on the eastern side by Millgarth-street.
To empower the Corporation to cover over, rearrange, and rebuild portions of the said market and otherwise improve the same, and to erect a slanghter-house and dead meat market in the Kirkgate Market, and to widen and make better approaches to Kirkgate Market.

2. To authorise the Corporation to erect on the North-street recreation ground, in the township and city of Leeds, a boilding or baildings for agricultural, horticultural, or cattle show parposes, for trade, industrial, and other exhibitions, for conservatories and winter gardens, for the bolding of meetings, concerts, and entertainments, and to provide for the fitting up, furnishing, and equipment of such building or buildings, and for securing good and orderly conduct therein, with power to charge for admission to the buildings and to let the same.

Street Works.
3. To empower the Corporation to make all or some of the following new roads and street works, all within the city and West Riding of the county of York, together with all necessary and proper works, bridges, embankments, retaining walls, junctions, connections, sewers, drains, approaches, and conveniences connected therewith or incident thereto.

Street Work No. 1.-A new road, wholly situate in the township of Leeds, commencing at a point in East-street at the junction of that street with Crown Pointroad and terminating in Marsh-lane at a point opposite to the house No. 33, Marshlane.

Street Work No. 2.-A widening of Eaststreet on the northern side, wholly situate in the township of Leeds, commeucing at Marsh-lane and terminating at the south-western corner of the Waterloo Inn in East-street.
Street Work No. 3.-A widening of Eaststreet on the southern side, wholly situate in the township of Leeds, commencing at a point opposite the house No. 49, Eaststreet and terminating in the mest northern corner of the house No. 50, East-street.
Street Work No. 4.-A widening of Eaststreet on the norther side, wholly situate in the township of Leeds, commencing at the eastern side of Smithies-street and terminating at the south-eastern corner of the house No. 161, East-street.
Street Work No. 5.-A new road, wholly situate in the township of Leeds, commencing at a point in East-street opposite to the house No. 161, East-street, and terminating on the southern side of Cross Green-lane at a point 12 feet measured in a south-easterly direction from the eastern side of Hago-street.
Street Work No. 6.-An improvement of the junction of Cross Green-lane with Easyroad and a widening of Easy-road on the northern side, wholly situate in the township of Leeds, commencing at a point in Cross Green-lane opposite the centre of Hagostreet and terminating in Easy-road at the south-westerr corner of Spring Close-view.
Street Work No. 7.-A widening of Rich-mond-street on the southern side and Ellorby-road on the eastern and western sides, wholly situate in the township of Leeds, commencing at Bow-street and terminating in Morpeth-street.
Street Work No. 8.-A widening of Zionstreet on the northern side, wholly situate in the township of Leeds, commencing at East-street and terminating at a point opposite to the entrance to Hardwicks yard.
Street Work No. 9.-A widening on the southern side and an extension of East King-street, wholly situate in the township of Leeds, commencing at East-street and terminating at Bow-street.
Street Work No. 10.-A widening and extension of Bow-street ou both sides, wholly situate in the township of Leeds, commencing at Richmond-street and terminating at Zion-street.
Street Work No. 11.-A widening of Cherryrow, partly on the eastern side and partly on the western side, and a widening on the westem side of Dolly-lane, wholly situats in the township of Leeds, commencing at Green-road and terminating at Roseville-terrace.
Street Work No. 12.-An extension of Gled-how-road, wholly situate in the township of Leeds, commencing at the southern end of Gledhow-road and terminating at the juuction of Dolly-lane with Rosevilleterrace.
Street Work No. 13.-A widening of Cross Stamford-street, partly on the eastern side and partly on the western side, and wholly situate in the township of Leeds, commencing at Skinner-lane and terminating at Benson-street.
Street Work No. 14.-A widening of Waterlooroad, partly on the westeru side and partly on the eastern side, and wholly situate in
