To incorporate a Company (herein referred to as "the Company") and to enable them to make and maintain in the County of Leicester the railway hereinafter mentioned, or some part or parts thereof respectively, with all needful works, stations, approaches, sidings, lifts, statifs, tips (hydraulic or otherwise), machinery, appliances, and conveniences connected therewith respectively, and to stop up or divert such streets, roads, and footpaths as are shown on the deposited plans hereinafter referred to relating to the said railway as intended to be stopped up or diverted (that is to say):—

A railway wholly in the County of Leicester, commencing in the parish of Loughborough, in the Borough of Loughborough, by a junction with the London Extension of the Great Central Railway now in course of construction, at or near the bridge carrying the Beeches-lane over that railway, and passing from, in, through, or into the said parish of Loughborough, and the parish of Knight Thorpe, in the Borough of Loughborough, and the parishes of Woodthorpe, Thorpe-Acre-with-Dishley, Garendou, and Nanpaatan, in the Rural District of Loughborough, and the parish of Sheepshed, in the Urban District of Sheepshed, or some of them, and terminating in the said parish of Sheepshed, in or near the south-east corner of field Nod. 648 on the 25-in. Ordnance Map of Leicestershire, sheet XVII.--10.

2.
