WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the seventh and eighth years of Her Majesty chapter ninety-four of the Act of the thirteenth and fourteenth years of Her Majesty chapter ninetyfour and of the Act of the thirty-second and thirty-third years of Her Majesty chapter ninetyfour duly prepared and laid before Her Majesty in Council a scheme or representation bearing date the third day of November, in the year one thousand eight hundred and ninety-eight, in the

England, acting under the provisions of the Act of the seventh and eighth years of Your Majesty chapter ninety-four, of the Act of the thirteenth and fourteenth years of Your Majesty chapter ninety-four, and of the Act of the thirty-second and thirty-third years of Your Majesty chapter ninety-four, have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Saint Paul Penzance and of the new parish of Saint John the Baptist Pen-zance both in the county of Cornwall and in the diocese of Truro.

"And whereas the said district chapelry of Saint Paul Penzance has under the provisions of the Act of the nineteenth and twentieth years of Your Majesty chapter one hundred and four lecome a new parish of the character contemplated by the Act of the sixth and seventh years of Your Majesty chapter thirty-seven and by the above-mentioned Act of the thirty-second and thir:y - third years of Your Majesty chapter ninety-'our.
