for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter one hundred and thirteen, and of the Act of the seventeenth and eighteenth years of Her Majesty, chapter eighty-four, duly prepared and laid before Her Majesty in Council a scheme bearing date the third day of November, in the year one thousand eight hundred and ninety-eight, in the words following, that is to say :-

"We the Ecclesiastical Commissioners for England, in pursuance of the Act of the third and fourth years of Your Majesty, chapter one hundred and thirteen, and of the Act of the seventeenth and eighteenth years of Your Majesty, chapter eighty-four, have prepared and now humbly lay before Your Majesty in Council the following scheme for apportioning the income of the benefice (being a vicarage) of Arksey in the county of York, and in the diocese of York, between that benefice, and a certain other benefice, namely the benefice and district chapelry of Saint Peter, Bentley, which said last-named benefice is situate in the said county of York, and in the said diocese of York.

"Whereas Sir William Henry Charles Wemyss Cooke of Wheatley Park in the said county of York, Baronet, is the patron of the said benefice of Arksey and also of the said benefice of Saint Peter, Bentley.

"And whereas it has been made to appear to us that the said benefice of Saint Peter, Bentley, is at present insufficiently endowed, and that the said benefice of Arksey has endowments of such an amount as that after the apportionment hereinafter recommended and proposed to be made shall have been made the said benefice of Arksey will still be sufficiently endowed.

"And whereas the Right Honourable and Most Reverend William Dalrymple, Archbishop of York, and the said William Henry Charles Wemyss Cooke have represented to us, and we are of opinion that it is desirable that additional provision should be made for the cure of souls within the district chapelry of Saint Peter, Bentley aforesaid, by means of that apportionment of the income of the said benefice of Arksey which is hereinafter recommended and proposed.

"And whereas the said benefice of Arksey is now full and the Vicar or Incumbent thereof the Reverend Thomas Todd, Clerk in Holy Orders, is willing that the said apportionment shall be made accordingly and has executed this scheme in token of such his willingness.

"Now therefore with the consent of the said William Dalrymple, Archbishop of York, acting as Archbishop of the Province and as Bishop of the diocese within which each of the said two benefices is situate (in testimony whereof he the said Archbishop has signed this scheme and has sealed the same with his Archiepiscopal Seal) and

with the consent of the said William Henry Charles Wemyss Cooke as the patron of each of the said two benefices as aforesaid, and with the consent of the said Thomas Todd, as Vicar or Incumbent of the said benefice of Arksey as aforesaid (in testimony whereof they the said William Henry Charles Wemyss Cooke and Thomas Todd have also signed and sealed this scheme) We, the said Ecclesiastical Commissioners humbly recommend and propose that as from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme, and without any conveyance or assurance in the law other than such duly gazetted Order, all that sum of one thousand four hundred pounds now held by us the said Ecclesiastical Commissioners in trust for the said benefice of Arksey, and in respect of which we pay to the Incumbent of such benefice by half yearly payments a sum of forty-two pounds per annum, shall be transferred from the said benefice of Arksey to the said benefice of Saint Peter Bentley, such sum of one thousand four hundred pounds to be held and applied by us the said Ecclesiastical Commissioners for the benefit of the Incumbent for the time being of the said benefice of Saint Peter Bentley.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of either of them or of any other Act of Parliament.'
