MERCHANT SHIPPING ACT, 1894.

NOTICE is hereby given that, after the expiration of forty days from the date hereof, it is proposed to submit to Her Majesty in Council, in pursuance of the above-mentioned Act, the draft of an Order in Council approving certain Pilotage Bye-laws made by the Pilotage Authority for the Harbour of Port Talbot.
