To all to whom these presents shall come, the Ecclesiastical Commissioners for England send greeting:

WHEREAS a new church has lately been built within the new parish of Saint John the Evangelist, Wortley de Leeds, in the county of York, and in the diocese of Ripon, and has been consecrated and dedicated to Saint John the Evangelist.

And whereas the Right Reverend William Boyd, Bishop of the said diocese of Ripon, as such Bishop, John Smyth Smyth-Osbourne, of Ash, in the parish of Iddesleigh, in the county of Devon, one of Her Majesty's Justices of the Peace, James Hargreave Nussey, of Fawcett House, Wortley de Leeds aforesaid, Cloth Manufacturer, Arthur Ingham, of Heaton Lodge, Wortley de Leeds aforesaid, Gentleman, Frederick William Halliday, of Ripley Lodge, Wortley de Leeds aforesaid, Surgeon, and Ernest Octavius Wooler, of Elsdon House, Wortley de Leeds aforesaid, Solicitor, as the patrons of the vicarage of the said new parish of Saint John the Evan-gelist, Wortley de Leeds, and the Reverend Edward Wilcox, Clerk in Holy Orders, as the Vicar or Incumbent of the same vicarage, have, by an instrument under their hands, bearing date on or about the twenty-fifth day of October, in the year one thousand eight hundred and ninetyeight, certified to us, the said Ecclesiastical Commissioners for England, that it would be for the convenience of the said new parish of Saint John the Evangelist, Wortley de Leeds, that the said new church of Saint John the Evangelist situate within such new parish, should be substituted for the old parish church (also dedicated to Saint John the Evangelist) of the same new parish.

Now therefore we, the said Ecclesiastical Com-

missioners for England, in exercise and execution of the power or authority in that behalf contained in the Act of the eighth and ninth years of Her present Majesty, chapter seventy, and in the Act of the ninetcenth and twentieth years of Her said Majesty, chapter fifty-five, and of all other powers or authorities in anywise enabling us in the same behalf, do, by this instrument, under our common seal, with the consents (testified as hereinafter mentioned) of the said William Boyd, Bishop of the said diocese of Ripon, and of the said John Smyth Smyth-Osbourne, James Hargreave Nussey, Arthur Ingham, Frederick William Halliday, Ernest Octavius Wooler, and Edward Wilcox, hereby declare that the said new church of Saint John the Evangelist, situate within the said new parish of Saint John the Evangelist, Wortley de Leeds, and duly consecrated as aforesaid, shall be and the same is hereby substituted for the said old parish church (dedicated to Saint John the Evangelist as aforesaid) of the same new parish, and that such new church shall henceforth be the parish church of the said new parish of Saint John the Evangelist, Wortley de Leeds, in lieu of the said old parish church of Saint John the Evangelist, as fully in all respects as if the said new church of Saint John the Evangelist, so hereby substituted, had been originally the parish church of the same new parish.

And we, the said Ecclesiastical Commissioners for England, in further pursuance and exercise of the powers and authorities aforesaid, and with such consents as aforesaid (testified as hereinafter mentioned), do hereby transfer all the endowments, emoluments, and rights of or belonging to the said old parish church (dedicated to Saint John the Evangelist as aforesaid) of the said new parish of Saint John the Evangelist, Wortley de Leeds, or of or belonging to the Vicar or Incumbent thereof, to the said new church of Saint John the Evangelist (now being by virtue of these presents the parish church of the said new parish of Saint John the Evangelist, Wortley de Leeds), and to the Vicar or Incumbent thereof, and his successors for ever.

In witness whereof to these presents, we, the said Ecclesiastical Commissioners for England, have set our common seal, and the said William Boyd, Bishop of the said diocese of Ripon, has set his hand and affixed his episcopal seal, and the said John Smyth Smyth - Osbourne, James Hargreave Nussey, Arthur Ingham, Frederick William Halliday, Ernest Octavius Wooler, and Edward Wilcox have respectively set their hands and affixed their seals, this first day of December, in the year one thousand eight hundred and ninety-eight.
