

1. Bedminster Sub-District to include the whole of Bedminster East and Bedminster West Municipal Wards, excepting only those small parts which now form part of St. Mary Redcliffe Sub-District, No. 3 Polling District of Somerset Ward, and Bedminster Polling District of Redcliffe Ward. This Sub-District will include the whole of that part of Bedminster Sub-District of Bedminster Registration District now situated within the city and union of Bristol (excluding the area which now forms part of Nos. 1 and 2 Polling Districts of Somerset Ward), and also those parts of No. 3 Polling District of Somerset Ward formerly included in Bedminster Without, Long Ashton, Easton-in-Gordano, Porthbury, and Portishead Civil Parishes.
2. Clifton Sub-District to include the whole of Clifton and Westbury Wards, and Westbury Polling District of St. Michael's Ward. This Sub-District will correspond with the present Clifton Sub-District of Barton Regis Registration District, except that it will not include those parts of the City and Union of Bristol which were formerly situated in Shirehampton Civil Parish.
3. St. Augustine Sub-District, as now constituted, and including the whole of St. Augustine and St. James Wards, and St. Michael's Polling District of St. Michael's Ward.
4. St. Paul Sub-District, as now constituted, and co-extensive with St. Paul Ward.
5. St. Mary Redcliffe Sub-District, as now constituted, and including Bristol Ward, Redcliffe Polling District of Redcliffe Ward, and small parts of Bedminster East and Bedminster West Wards.
6. St. Philip and Jacob Sub-District to correspond with the present St. Philip and Jacob Sub-District of Barton Regis Registration District, and to include the whole of St. Philip North and St. Philip South Wards, and St. Philip Polling District of Redcliffe Ward.
7. Knowle Sub-District to include Polling Districts Nos. 1 and 2 of Somerset Ward.
8. St. George Sub-District to correspond with the present St. George Sub-District of Barton Regis Registration District, and to include the whole of St. George and Easton Wards.
9. Stapleton Sub-District to include all that part of the present Stapleton Sub-District of Barton Regis Registration District which is situated within the City and Union of Bristol and is co-extensive with Stapleton Ward.
10. Ashley Sub-District to include all that part of the present Ashley Sub-District of Barton Regis Registration District which is situated within the City and Union of Bristol, with the addition of the area formerly part of Shirehampton Civil Parish, now forming part of the City and Union of Bristol. This Sub-District will include the whole of the District and Horfield Wards.

These changes to take effect on the 1st January, 1899.
