By an Order made by Mr. Justice Wright in the above matters dated the 14th day of December 1898 on the petition of the Law Investment and Insurance Corporation Limited creditors of the above named Company praying that an Order might be made for the winding up of the said National Cycle and Motor Car Insurance Company Limited it was ordered that the voluntary winding up of the said National Cycle and Motor Car Insurance Company Limited be continued but subject to the supervision of the Court and any of the proceedings under the said voluntary winding up might be adopted as the Court should think fit. * Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the local inspector of Corn Returns in any other measure than the imperial bushel or by weight or by a weighed measure that officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.
