WILD BIRD (ENGLAND). The Wild Birds Protection (Administrative County of Derby) Order, 1899. Dated 21st January, 1899.

IN pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1896, and upon application by the County Council of the Administrative County of Derby, I hereby make the following Order:

1. This Order may be cited as the Wild Birds Protection (Administrative County of Derby)

Order, 1899. 2. "The Wild Birds Protection Act, 1880," shall apply within the County of Derby to the Heron and to the Kestrel in the same manner as if those birds had been included in the schedule to the Act.

3. The time during which the killing and taking of Wild Birds is prohibited by the Act of 1880, shall be extended throughout the County of Derby so as to be from the 1st day of March to the 12th day of August in each year.

4. The taking or destroying of the Eggs of the following species of Wild Birds is prohibited

throughout the County of Derby:

Owls (all species), Kestrel, Kingfisher, Goldfinch, Curlew.
5. The Order of the 5th March, 1896, is

hereby repealed.

FACTORY AND WORKSHOPS ACTS, 1878 TO 1895.
