

**ORDER of the Local Government Board :**  
**District Auditor : Assignment of District and**  
**Duties (County Councils) :—**

Eastern Counties Audit District,  
 To: Thomas Howel Kyffin Roberts, District  
 Auditor ;—  
 To the County Councils of the several Admin-  
 istrative Counties named in the Schedule to  
 this Order, and to the County Council of the  
 Administrative County of Kent ;—  
 To the Visiting Committees of any Lunatic  
 Asylums belonging wholly or in part to one  
 or more of the said County Councils and not  
 belonging in part to any other County  
 Council ;—  
 To the Local Fisheries Committee for the  
 Kent and Essex Sea Fisheries District ;—  
 And to all others whom it may concern.

WHEREAS by Section 4 of the District  
 Auditors Act, 1879, it is enacted that the Local  
 Government Board may from time to time assign  
 to District Auditors their duties, and the Districts  
 in which such Auditors respectively are to act, and  
 may from time to time change wholly or in part  
 such Duties or Districts ;

And whereas by an Order dated the 16th day  
 of June, 1897, We, the Local Government Board,  
 certified the appointment of the said Thomas  
 Howel-Kyffin Roberts as a District Auditor, and  
 directed that, unless We otherwise prescribed, it  
 should be the duty of the said District Auditor to  
 audit the Accounts of the County Councils of the  
 several Administrative Counties named in Schedule  
 A to that Order and the other Accounts referred  
 to in Article I of the said Order, so far as the  
 same might relate to any period prior to the 1st  
 day of April, 1897 ; and We further directed that  
 the District in which the said Thomas Howel  
 Kyffin Roberts should act as Auditor, and which  
 should be termed the " Eastern Counties Audit  
 District," should, for the performance of the duties  
 assigned to him by Article I of the said Order,  
 comprise the area for the time being included in  
 the said several Administrative Counties and the  
 area comprised in the Kent and Essex Sea  
 Fisheries District ;

And whereas by an Order dated the 16th day of  
 March, 1898, We altered the said Order dated the  
 16th day of June, 1897, by the substitution in  
 Article I thereof of the words " first day of April,  
 one thousand eight hundred and ninety-eight," for  
 the words " first day of April, one thousand eight  
 hundred and ninety-seven," ;

And whereas it is expedient that the said Order  
 should be further altered as hereinafter men-  
 tioned :

Now therefore, in pursuance of the powers  
 given to us in that behalf, We hereby alter the  
 said Order dated the sixteenth day of June, one  
 thousand eight hundred and ninety-seven (as  
 altered by the said Order dated the sixteenth day  
 of March, one thousand eight hundred and ninety-  
 eight), by the substitution in Article I thereof of  
 the words " first day of April, one thousand eight  
 hundred and ninety-nine," for the words " first  
 day of April, one thousand eight hundred and  
 ninety-eight" ; and We do hereby Order that the  
 said Order as so altered shall have full force and  
 effect as if the words hereby substituted therein  
 had been originally contained in such Order.

**Duties (County Councils) : Supplemental Districts**  
**and Duties :—**

Midland Counties Audit District.

To William Dewse Easterby, District  
 Auditor ;—

To the County Councils of the several Admin-  
 istrative Counties named in the Schedule to  
 this Order ;—

To the Visiting Committees of any Lunatic  
 Asylums belonging wholly or in part to one  
 or more of the said County Councils and not  
 belonging in part to any other County  
 Council ;—

To the South Rotherham, Handsworth and  
 Kiveton Park District Isolation Hospital  
 Committee ;—

To the Penistone District Isolation Hospital  
 Committee ;—

And to all others whom it may concern.

WHEREAS by Section 4 of the District  
 Auditors Act, 1879, it is enacted that the Local  
 Government Board may from time to time assign  
 to District Auditors their Duties, and the Districts  
 in which such Auditors respectively are to act,  
 and may from time to time change wholly or in  
 part such Duties or Districts ;

And whereas by an Order dated the 16th day  
 of June, 1897, We, the Local Government Board,  
 certified the appointment of the said William  
 Dewse Easterby as a District Auditor, and  
 directed that the District in which the said  
 William Dewse Easterby should act as Auditor,  
 and which should be termed the " Midland  
 Counties Audit District," should, for the per-  
 formance of the duties assigned to him by  
 Article I of the said Order, comprise the area for  
 the time being included in the several Adminis-  
 trative Counties named in Schedule A to that  
 Order, and should, for the performance of the  
 duties assigned to him by Article II of the said  
 Order, comprise the area for the time being  
 included in the several Unions named in  
 Schedule B to that Order, the Districts named in  
 paragraphs (3) and (4) of the said Article II, and  
 the Districts or areas subject to the jurisdiction of  
 any such Authority as was mentioned in para-  
 graph (6) of the said Article II ;

And whereas by Article I of the said Order,  
 We directed that, unless We otherwise prescribed,  
 it should be the duty of the said District Auditor  
 to audit the Accounts of the County Councils of  
 the several Administrative Counties named in  
 Schedule A to that Order and the other Accounts
