FOREIGN AND COLONIAL POST. MALTA

IN pursuance of the Rules Publication Act. 1893, Her Majesty's Postmaster-General hereby gives notice that a Warrant, dated the 24th day of March, 1899, has been made on his repre-sentation by the Commissioners of Her Majesty's Treasury, in pursuance of the Post Office Acts, ordering, directing, and declaring that, on and from the 1st day of April, 1899, the Foreign and Colonial Post Warrant, 1898, shall apply to letters transmitted to and from Malta, as if Malta were specified in the Second Schedule of the lastnamed Warrant.
