Forms for the purpose can be obtained at the Lord Chamberlain's Office.

Gentlemen who wish to be presented officially should communicate with the heads of their Department, who will provide them with the necessary cards and instructions.

No. 85.—Government Notice. His Excellency the Governor, having heard the opinion of the Board of Health, has been pleased

January, 1899, and to direct that the following Regulations be observed, viz. :-

- 1. Vessels which are not allowed to enter the harbour, but are allowed to communicate in quarantine with the Islands of Comino and Cominotto under such restrictions as the Collector of Customs may direct.
- (a.) Vessels that have on board, or have had during the voyage, cases of cholers, yellow fever or plague, or cases of a disease with symptoms resembling those of cholera, yellow fever, or plague

(b.) Vestels with pilgrims from the East.

- (c.) Vessels arriving from Arabian ports in the Red Sea and the Persian Gulf, which have not been admitted to free pratique at Suez and Port Said.
 - 2. Vessels which are allowed to enter the Quarantine Harbour to coal and take in provisions under quarantine restrictions.
- (a:) Vessels arriving from Indian ports without clean bill of health, which have not been admitted to free pratique in a port in the Adriatic or Mediterranean Sea, or which have not, to the satisfaction of the Chief Government Medical Officer, been thoroughly disinfected before being admitted to free pratique at the said port.

(b.) Vessels arriving from any port without a clean bill of health, which do not fall under any

of the preceding regulations.

Vessels without a clean bill of health that carry a doctor, may complete a period of ten days' quarantine, reckoned from date of departure, either at sea or at the anchorage of Comino, before being admitted under the same conditions as arrivals from Bombay.

3. Medical Inspection.

All vessels arriving at Malta shall undergo strict medical inspection.

4. Passengers.

Passengers arriving from Bombay, Kurrachee, and Calcutta shall be landed in one of the quarantine establishments where they will be subjected to strict medical inspection until their clothing and all other articles of personal use, likely to retain infection, shall have been thoroughly disinfected.

5. Goods.

The importation of coffee-beans or groundcoloured with substances injurious to health is prohibited.

The importation of cotton seed from any port subject to quarantine is forbidden.

The importation of rags is prohibited.

The importation is forbidden before disinfection of the following articles, viz., wearing apparel, soiled linen and clothing, bedding materials, feathers, bones, and jute goods.

The importation of hides from any port subject to quarantine, or from any place where cattle disease exists, is prohibited before disinfection.

The importation of vines, vine shoots, and fruit packed in vine leaves is prohibited. The importation of plants or roots from any port of the Mediterranean is prohibited, unless the same are accompanied by a satisfactory certificate that phylloxera is not known to exist at the place of By command, origin.

His Excellency the Governor, having heard the opinion of the Board of Health, has been to modify Government Notice No. 2 of the 2nd | pleased to modify Government Notice No. 29 of 1st February, 1899, and to direct that the following Regulations be observed, viz.:—

1. The Importation is forbidden of:

(a.) Cattle (except horses, mules, and asses) from Egypt, the Province of Naples, Calabria, and Salonica;

(b.) Wool, hides, skins, horns, bones, and hoofs from the above places and from countries where

epidemic diseases are reported;

- (c.) Cattle arriving from any place, if affected with any disease in view of which, in the opinion of the Chief Government Medical Officer, their admission into the Lazaretto might prove detrimental to other cattle already in the Island.
 - 2. Cattle which may be allowed to be landed under the conditions hereinafter specified, and subject to their being kept isolated and under observation in such of the enclosures at the Lazaretto as may be assigned or approved for that purpose for the period hereinafter stated.

(o.) Cattle from the Black Sea, Sea of Azov, Syria, and Roumelia (unless the importation is otherwise prohibited)—subjected to three months'

observation;

(b.) Horses, mules, and asses from Egypt, the Province of Naples, Calabria, and Salonica—subjected to three days' observation, provided that such horses, mules, and asses shall be released, after inspection at the Lazaretto, if the owner undertake to keep the animals in a place approved of by the Collector of Customs, and to cause them to be inspected by a Government Medical Officer or Veterinary Surgeon twice a week for nine weeks.

The cattle referred to in this paragraph shall not be allowed to be landed, unless the consignee shall have in each case, and before shipment, made a written application, stating the approximate number of animals intended to be imported, and obtained the necessary permission after having agreed to abide by any regulations which may be established. Such application shall imply that the consignee has bound himself to abide by any regulations which may be in force on the day of importation, or which may be issued during the time in which the cattle may have to remain in quarantine, and also to pay the entrance fees, fees for guards, and other fees for ordinary or extraordinary expenses usually levied on cattle at the Lazaretto.

3. Swine.

. Swine arriving from Albania and Greece may be imported subject to forty days' quarantine at the Lazaretto or in private enclosures, and to any restrictions which the Chief Government Medical Officer may consider necessary.

4. General Provisions.

All cattle intended for importation into these Islands must be accompanied by a certificate from the British Consular Authority, or, in default, of the Local Government Authority of the places of origin and embarkation, stating that cattle disease has not been officially reported in those places during the three months previous to the date of embarkation.

The term cattle in this paragraph includes horses, mules, asses, animals of the bovine species, sheep, goars, and swine.

5. Vessels with Cattle on Board.

Vessels arriving in this Island, having on board more than 250 head of cattle (bovine), are to go into the quarantine harbour, and the cattle are to be inspected in the cattle enclosures of the Lazaretto.

6. Dogs.

The importation of dogs is subjected to three months' quarantine.

WILD BIRD (ENGLAND). The Wild Birds Protection (County of Cambridge) Order, 1899. Dated 7th April, 1899.

WHEREAS by section 2 of "The Wild Birds Protection Act, 1894," power was given to one of Her Majesty's Principal Secretaries of State, upon application by the County Council of any Administrative County, by Order to prohibit the taking or destroying of Wild Birds' eggs in any year or years in any place or places within that

And whereas by an Order under my hand bearing date the 23rd September, 1895, granted upon the application of the County Council of the Administrative County of Cambridge, the taking or destroying of Wild Birds' e.gs within that part of the County of Cambridge known as Wicken Sedge Fen was prohibited for a period of three years from the 7th September, 1895.

And whereas the said County Council have applied to me requesting that an Order may be made to prohibit the taking or destroying of Wild Birds' eggs within the said part of the County of Cambridge for a further period, namely, five years.

Now therefore, I, the Right Honourable Sir Matthew White Ridley, Bart., one of Her Majesty's Principal Secretaries of State, in pursuance of the said Act, and on such application as aforesaid, hereby order as follows:

That the taking or destroying of Wild Birds' eggs within that part of the County of Cambridge known as Wicken Sedge Fen shall be prohibited for a period of five years from the date of this Order.

WILD BIRD (ENGLAND). The Wild Birds Protection (County of Norfolk) Administrative Order, 1899. Dated 7th April, 1899.

IN pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1896, and upon application by the County Council of the Administrative County of Norfolk, I hereby make the following Order:-

I. This Order may be cited as the Wild Birds Protection (County of Norfolk) Order, 1899.

Eggs.

All Eggs Protected in certain Areas. II.—(1.) The taking or destroying of the eggs of any species of Wild Bird is prohibited during the period expiring on the 30th day of April,

Sounds, Blackfleet Broad, Horsey Mere, Martham and Somerton Broads, and the rands, skirts, and walls thereof, and fens and reed grounds appertaining thereto respectively, and the islands therein, and the dykes communicating therewith, including the Hundred Stream or Thurne River and ancient bed, and the rands and walls thereof from Heigham Bridge to the sea at Winterton, and all the marshes and low-lying and uncultivated lands, fens, reed grounds, warrens, marram or sand hills and sea shore, to the line of high water mark, in the several parishes of Waxham, Horsey, Potter Heigham, and Hickling, and such part of the parish of Catfield as lies to the east of the Midland and Great Northern Joint Railway.

(b) The warrens, marram or sand hills and sea shore, to the line of high water mark, in the parish of Winterton.

(c) The series of Broads known as Ormesby. Rollesby, Hemsby, Filby, and Burgh Broads, and the rands, skirts, and walls thereof, and the dykes communicating therewith, and the fens, reed grounds, and low-lying lands, marshes, and pastures adjacent thereto, including Lady Broad or Hard Fen Water, in the parish of Filby, Brandyke Broad, in the parish of Burgh St. Margaret, and Muckfleet Dyke, and the marshes and lowlying lands and pastures near or adjacent thereto respectively.

(d) The whole of the foreshore of the county of Norfolk, including the shingle, sand hills, salt marshes, creeks, and other unenclosed lands extending from high water mark to the first boundary of enclosed or cultivated land separating the fore-

shore from them.

Certain Eggs Protected throughout the County.

(2.) The taking or destroying of the eggs of the following species of Wild Birds is prohibited throughout the County of Norfolk, viz.:-1. Bearded Titmouse or Reed Pheasant (Panurus biarmicus). 2. Crossbill (Loxia curvirostris). 3. Owls—all species. 4. Wild Ducks and Teal—all species. 5. Norfolk Plover, Stone Curlew, or Thickknee (Œdicnemus scolopax). 6. Rough or Reeve (Machetes pugnax). 7. Ring Dotterel, Ring Plover, or Stone Runner (Ægialitis hiaticula). 8. Oyster Catcher or Sea Pie (Hæmatopus etterleren). ostralegus). 9. Terns, Sea Swallows, Pearls or Dipears (Sterna)—all species: 10. Great Crested Grebe or Loon (Podicipes cristatus). 11. Kingfisher (Alcedo ispida). 12. Sandmartin (Cotyle riparia).

BIRDS.

Additions to Scheduls of Act of 1880.

III. The Wild Birds Protection Act, 1880. shall apply within the County of Norfolk to the following species of Wild Birds in the same 1900, within the following areas:—

(a) Hickling Broad, Whitesley and Heigham following species of Wild Birds in the same manner as if those species were included in the schedule to the Act :- Bearded Titmouse or Reed Pheasant, Crossbill, Sandmartin.

Extension of Close Time throughout the County

IV. The period during which the killing or taking of Wild Birds is prohibited by the Act of 1880 shall be extended throughout the County of Norfolk, so far as regards all Birds mentioned in the schedule to that Act, except the Snipe, Teal, and all species of Wild Duck, so as to be from the 1st March to the 31st August in any year.

All Birds Protected on Sundays in certain Areas. V. During the period from the 1st day of September in any year to the last day of February following, the taking or killing of Wild Birds on Sundays is prohibited within the areas described in Article II, paragraph (1), sub-paragraphs (a),

(b), (c), and (d) of this Order.

VI. The Order of the 6th April, 1898, is

hereby repealed.

ORDER OF THE BOARD OF AGRICULTURE.

(DATED 5TH APRIL, 1899.)

(Swine-Fever Infected Areas.)

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of

every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Revocation of Orders.

1. The Orders described in the First Schedule to this Order are hereby from and after the commencement of this Order revoked: Provided that such revocation shall not invalidate or make unlawful anything done under the Swine-Fever (Infected Areas) Order of 1896 and the Orders described in the First Schedule to this Order before the commencement of this Order, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, those Orders before the commencement of this Order.

Declaration of Swine-Fever Infected Area.

2. The Area described in the Second Schedule to this Order is hereby declared to be an area infected with swine-fever for the purposes of the Swine-Fever (Infected Areas) Order of 1896.

Commencement.

3. This Order shall come into operation on the eighth day of April, one thousand eight hundred and ninety-nine.
