"3. Every owner of a locomotive to which the County Council may have ordered that an original licence be granted shall pay in respect of every such licence a fee of £10, but if the weight of such locomotive (exclusive of water and coal) exceeds 10 tons then an additional fee of $\pounds 2$ shall be charged for every ton or fraction of a ton above that weight.

" Additional Licence.

" 4. Where at the time of the application for the licence the owner may notify to the County Council that the locomotive is already licensed in any other county, and where the owner shall produce to the Council the licence which may have been granted for the use of such locomotive in such other county, the owner shall, in substitution for the fee hereinbefore specified, pay for such first-mentioned licence a fee of £5, but if the weight of such locomotive (exclusive of water and coal) exceeds 10 tons, then an additional fee of £1 shall be charged for every ton or fraction of a ton above that weight.

" Use of Locomotive on Payment of Fee without Licence.

" 5. A locomotive requiring to be licensed shall not be used in the county until so licensed or until, in case of temporary uses, a fee of 2s. 6d. per day has been paid to the Clerk of the Council in respect of every day during which it will be so used. The owner of the locomotive when making the payment shall inform the County Council what is the destination of the locomotive and for what purpose it is being used.

" Penalties.

" 6. Every person who shall offend against any of the foregoing Bye-laws shall be liable for every such offence to a penalty not exceeding £5.
