Amur River-Tidal Signals and Beacon Lights. THE Russian Government has given notice, dated 2nd March, 1899, that in addition to the signals made in the day, the following signals will be made at night from the semaphores on Points Djaore and Prongé, to indicate the depth of water on the bar of the Amur River :-

a. One red light at the mast head indicates a depth of 12 feet on the bar.

f. In addition to the above, one red light at each yard-arm indicates an additional or less depth of ‡ foot.

g. In addition to the above, one white light at the right yard-arm indicates an additional or less depth of $\frac{3}{4}$ foot.

If the above fractions are to be added to the depth shown by the lights at the masthead, a red light will be shown below the light indicating the fraction; if to be subtracted, a white light will take the place of the red light.

With a rising tide, a red light, and with a falling tide, a white light, will be hoisted on the left yard-arm.

Also, in order that vessels of 12 feet draught may use the channel leading to Nikolaevsk at night, white fixed lights, visible only on northwesterly bearings, have been place on the leading beacons.
